Heroin and Opioid Crisis Interagency Coordination Survey

During the 2017 Regular Legislative Session, Act 88 established the Advisory Council on Heroin and Opioid Prevention and Education (HOPE). The Council's purpose is to create an Interagency Heroin and Opioid Coordination Plan, coordinate parish-level data on opioid overdoses and usage of overdose-reversal medication (Naloxone), and coordinate a central online location to disseminate information and resources, including the Interagency Heroin and Opioid Coordination Plan. Two sub-committees were formed to address this body of work: a Data Workgroup, and an Interagency Coordination Plan Workgroup.

The objective of the Interagency Coordination Plan Workgroup is to coordinate and organize existing initiatives and resources to assist in developing a statewide coordination plan. We are asking for your participation in this survey so we may gather information on heroin and opioid initiatives taking place within your organization **since July 1, 2016 (State Fiscal Year 2017)** and the impacts of these initiatives. A. Describe initiative:

Although we have no current initiative to address the Opioid crisis our officers on a daily basis try to gather information received from citizen complaints, investigative leads and information from suspect interviews to identify suspected street level drug sales, suspected users in problem areas. The officers try to be highly visible in trouble areas so that citizens will immediately notice police presence. The officers will conduct surveillance operations, and conduct traffic stops on suspect vehicles in the problem areas. The officers will work with other drug task force units working in the City of Pineville.

The officers patrol the numerous feeder roads that enter and exit the problem areas to disrupt the transportation of narcotics coming into the City of Pineville. These operations will be directed toward gathering evidence for arrest and prosecution of the drug user and the lower to mid level street corner dealers. Any information gained that leads to sources outside the city limits of Pineville are passed on to the appropriate agency, be it Parish, State or Federal.
