 - ii. Minutes were approved.
- C. Review of Team Recommendations
 - i. Malcolm Broussard emphasized that members focus on the name of the Commission - ***Prevention*** of Opioid Abuse.
 - ii. Mr. Broussard gave an overview of how the draft recommendations were created:
 - Each team work group met and decided upon proposed recommendations, then proposed recommendations from each team were compiled into one document to be reviewed by the group.
 - Teams make contributions and recommendations, but Commission will make final determination.
 - Online survey tool, such as Survey Monkey, could be used to obtain final recommendations (one vote per Commission member).
 - iii. Review of recommendations from teams 1 – 4
 - 2.3 – change “required to “encouraged”
 - 2.4 – change “required to “encouraged” (it was noted that the WI Board of Medicine requires 1 hour of CME for physicians)
 - 3.3 – include in parentheses after the term “services” – “non-pharmacologic therapy including but not limited to occupational therapy, physical therapy and chiropractic health services as one of the primary treatment paths for managing chronic pain issues.” The reason for the change is that physical therapists are worried that “functional restoration programs” is not a nationally recognized program or licensed profession.
