Surveillance Summary – First Quarter 2025

State and National Context

In 2023, Louisiana ranked 4th in the nation for HIV diagnosis rates, with 18.8 new diagnoses per 100,000 people. For primary and secondary (P&S) syphilis, the state ranked 8th nationally, with a rate of 26.1 per 100,000. HIV burden remains especially high in Louisiana's largest metro areas: The Baton Rouge metropolitan statistical area (MSA) ranked 10th, and the New Orleans MSA ranked 6th for HIV diagnosis rates, with 21.3 and 23.1 diagnoses per 100,000 population, respectively. Louisiana also ranked 7th in the nation for congenital syphilis in 2023, with a rate of 193 cases per 100,000 live births, and a total of 109 cases reported.

HIV Trends

As of March 31, 2025, 23,880 people were living with HIV (PLWH) in Louisiana. Forty-seven percent (n=11,144) had received an AIDS diagnosis. In 2024, 939 people were newly diagnosed with HIV. Of those, 26% (n=248) were diagnosed in Region 1 (New Orleans), and 17% (n=160) in Region 2 (Baton Rouge). Gay, bisexual, and other men who have sex with men (GBM) continue to represent the leading reported risk factor for HIV acquisition in Louisiana. Among people newly diagnosed with HIV in 2024 who reported a risk factor, 59% identified as GBM, and an additional 3% identified as both GBM and persons who injects drugs. As of March 2025, 47% of all people living with HIV in Louisiana with a known risk factor were GBM.

Early Syphilis

From January 1 through March 31, 2025, 294 people were newly diagnosed with early syphilis in Louisiana. This included 153 cases of primary or secondary syphilis and 141 cases of early non-P&S syphilis. Regionally, 12% of these cases (n=36) occurred in Region 1 (New Orleans), and 14% (n=42) occurred in Region 2 (Baton Rouge). Among people diagnosed with early syphilis in Louisiana, the most commonly reported risk factor was heterosexual activity. As of March 31, 2025, 72% of those with a reported risk factor identified as heterosexual contact, 34% reported any form of illegal drug use, and 30% identified as gay, bisexual, or other men who have sex with men (GBM). Individuals could report more than one risk factor.

Congenital Syphilis

During the same period (January through March 2025), 11 mothers and 11 infants were linked to confirmed congenital syphilis cases. Among the mothers, 27% (n=3) resided in Region 4 (Lafayette), 72% (n=8) were Black, and 45% (n=4) were between the ages of 30 and 34 at the time of delivery. These data are preliminary and are subject to change.

Demographic Highlights and Disparities

Across HIV, AIDS, and early syphilis, the majority of new diagnoses continue to occur among men. In 2024, 73% of people newly diagnosed with HIV and AIDS were male, and in the first quarter of 2025, men accounted for 60% of early syphilis cases. Black Louisianans continue to experience disproportionate impacts from HIV and STIs. Although they represent only 32% of the state's population, Black individuals accounted for 64% of new HIV diagnoses and 71% of AIDS diagnoses in 2024. In the first quarter of 2025, 59% of early syphilis cases with a reported race/ethnicity were among Black individuals.

Adolescents and young adults remain highly affected. In 2024, 22% of new HIV diagnoses occurred in individuals aged 13 to 24, and 34% were among those aged 25 to 34. A similar pattern existed for early syphilis in the first quarter of 2025, with 26% of cases in the 13–24 age group, and 33% among those aged 25–34.

* A syphilis diagnosis with less than one year duration is considered to be "early syphilis." This designation covers the primary, secondary, and early non-P&S stages of syphilis.

Changes to Gender Variable

The gender variable now encompasses five genders: man, woman, transgender man, transgender woman, and additional gender identities. The gender category “additional gender identity” was added to include those who identified as gender queer, gender non-conforming, or non-binary. Gender defaults to birth sex unless a gender identity different from birth sex has been collected from medical chart review, case management notes, or during a partner services interview. People of transgender and additional gender identities are likely undercounted.

Changes to Syphilis Case Definition

The Quarterly Report includes revisions to the surveillance case definition for syphilis as approved by the Council of State and Territorial Epidemiologists (CSTE) effective January 1, 2018. Of note, the nomenclature for “Early latent syphilis” has been changed to “Early non-primary non-secondary syphilis.” Throughout the Quarterly Report, it has been abbreviated to “Early non-P&S syphilis.” Please refer to the following documentation for additional information on all other syphilis case definition revisions: <https://www.cdc.gov/std/stats/DCL-syph-case-def-sept-4-2017.pdf>.

Congenital Syphilis Case Definition

A case of congenital syphilis (CS) occurs when an infant is exposed to inadequately treated syphilis in utero or during delivery. This may result in stillbirth, death of the newborn, or significant future health and developmental problems. A wide spectrum of severity exists, from in apparent infection to severe cases that are clinically apparent at birth. An infant or child (aged less than 2 years) may have signs such as hepatosplenomegaly, rash, condylomata, snuffles, jaundice (nonviral hepatitis), pseudoparalysis, anemia, or edema (nephrotic syndrome and/or malnutrition). An older child may have stigmata (e.g., interstitial keratitis, nerve deafness, anterior bowing of shins, frontal bossing, mulberry molars, Hutchinson teeth, saddle nose, rhagades, or Clutton joints).



10-Year Trends in Persons Living with HIV Louisiana, 2015-2024





Louisiana, 2015-2024**









10-Year Trends in Early non-P&S Syphilis Diagnoses Louisiana, 2015-2024




