

Louisiana Long Term Care Processing Center


- ► Centralized, statewide processing center is located in Opelousas, LA.
- LTC Processing Center handles initial and ongoing eligibility for nursing homes, group homes and waivers around the state.

Four Distinct Processing Units		
Admin Unit	Receives and processes phone calls, mail, and fax	
Intake Unit	Receives and processes new applications	
Case Load Unit	Manages changes to existing cases	
Group Homes Unit	Manages cases for individuals with group homes

Medicaid Regulations for LTC

Timely Filings:

➤ Medicaid has 90 Days to complete application processing from the date the completed signed application is received.

1-L Application:

- ► Eligibility for LTC is based on medical and financial need.
- ► A 142 and 148 form must be submitted prior to an application.

Trusted Users: Stay informed

Features:

- Submit applications on behalf of residents
- ► View status for submitted applications
- Submit renewal information on behalf of residents

Requirements:

- ► Nursing Facility Satellite Location ID #
- ► Authorized representative forms
- ► Mandatory training
- ► Willing participation

Common Billing Issues

- Breaks in stay and bed hold
- ▶ Billing beyond date of death
- Expired 142 form
- ► Untimely provider forms
- ► Incorrect data such as case ID number in lieu of Medicaid ID number



Common Questions

- What is the current status of the application?
- □ The application is processed. Why is the member not eligible in MEVS?
- Why is my claim denied?
- How can I get more assistance?
- Do I need to re-bill on denial codes 568, 159, and 173?

Alert:

All LTC cases from the past 8 months need to be renewed during the month of May.





LTC Renewals in May

What You Need to Know

- ► Medicaid renewal letters for long term care enrollees will be mailed the first week in May
- ▶ Includes all enrollees with renewal date between November 1, 2018 and June 30, 2019.
 - This is roughly 75% of the long term care population, including some nursing facility and waiver recipients.
- Nursing facility staff that register as Trusted Users will be able to complete the renewal online on behalf of their residents that provide consent.
- ▶ All renewal letters will be sent to the authorized representative on file.
- ▶ Providers are encouraged to reach out to authorized representatives to ensure their proper address is on file with Medicaid.



Renewal Process

What to Expect

- ➤ Step 1: LDH will check eligibility in our system for all long term care enrollees who have a renewal date between November 1, 2018 and June 30, 2019.
- ► Step 2: Anyone that remains eligible within program limits based on data sources already available in the Medicaid system will be sent a Decision Letter noting their continued coverage.
- ▶ Step 3: Anyone that the system produces data indicating a discrepancy or that the person is over program limits will fall out to "standard renewal" and will receive a renewal letter.
- ▶ Step 4: LDH will provide nursing facilities and support coordination agencies on file with a list of persons in their care that received a renewal letter. Please work with these enrollees to assist them with submitting renewal information by the deadline indicated in the letter.
 - Requires the provider to be listed on enrollee's case in Medicaid system
- ▶ If they do not respond, they will lose coverage in June 2019.

Why were there LTC renewals in April?

Dual Eligibility

- Nursing facilities may have noticed some renewals in April
- ▶These were not sent in error
- The April renewal was focused on individuals who were dually enrolled in the Medicare Buy-In Program
 - The buy-in program pays Medicare premiums for eligible individuals
- ▶ Please be sure to complete the renewal or assist members with completing their renewal so they may continue coverage in the Medicare Buy-In Program
