Discussion of Outcomes Measures/ Tool	CSoC Dashboard – Sareda McPhee Participants were walked through the detail of the most recent dashboard, which includes CSoc-specific data on: Reduction of Out of Home Placements, Improved Outcomes, Utilization of Home and Community-Based Services, and Youth Receiving High-Quality Wraparound Care Coordination. The group discussed inpatient psychiatric hospitalization trends for CSoc and other MCO members. Dr. Savicki asked if FINS involvement is included in the involvement with juvenile justice measure, and Sareda confirmed that it is included. A composite measure will be added to the next dashboard to show the percentage of members with any agency involvement (DCFS, juvenile justice, and both combined). Dr. Savicki suggested adding a measure looking at OCDD involvement. Sareda agreed that this would be helpful, and will follow-up. Sareda shared that Magellan and the wraparound agencies will soon begin administering the fidelity survey using the WFI-EZ tool. Magellan plans to continue with the quality improvement plan around follow-up after hospitalization.
