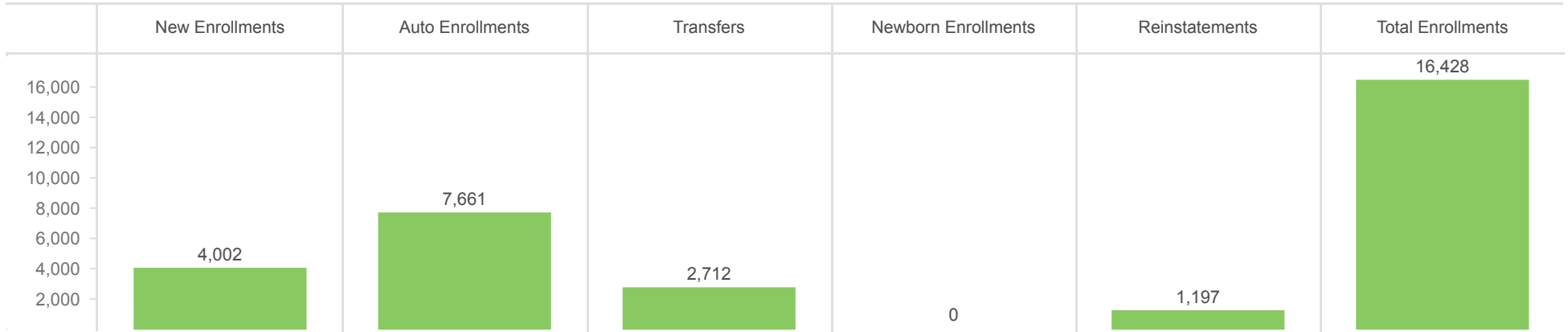




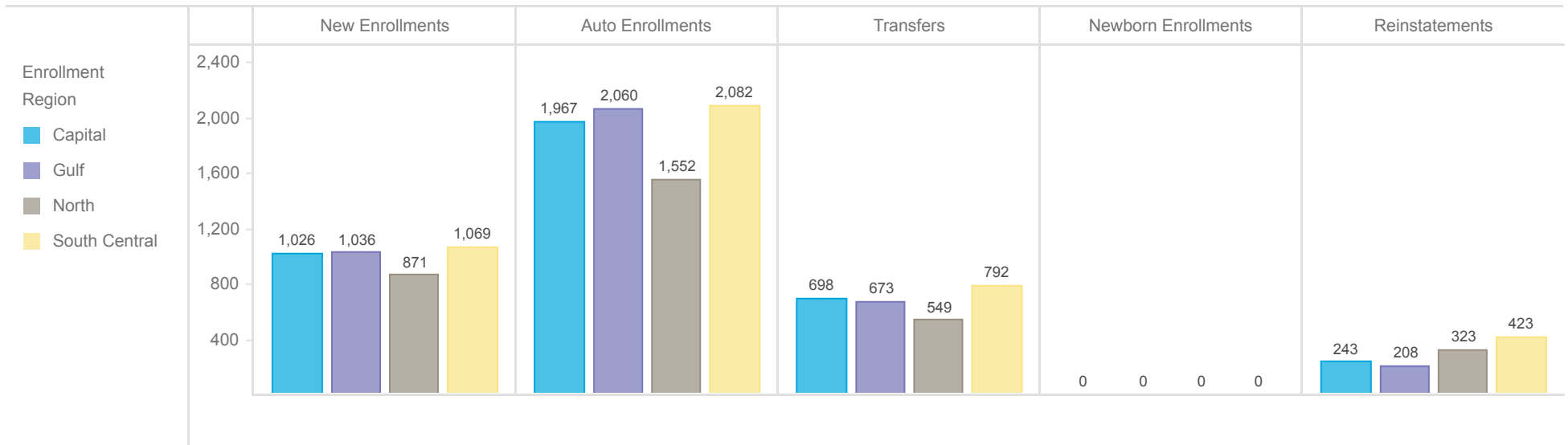
Healthy Louisiana Monthly Enrollment by Location - New Members Reporting Month: February 2023
