Single MCO PBM (Magellan)

The Single Pharmacy Benefits Manager (PBM) for Managed Care Organizations (MCO) original implementation of October 1, 2023 has been postponed. The new implementation date is October 28, 2023.

Effective October 28, 2023, Magellan Medicaid Administration Inc. will process all Medicaid MCO pharmacy claims. Magellan will serve as the single PBM for all six MCOs (Aetna, AmeriHealth Caritas, Healthy Blue, Humana Healthy Horizons, Louisiana Healthcare Connections, and United Healthcare).

Currently Magellan is only processing **test** claims. All claims with a date of service prior to October 28, 2023 should be billed to the MCO PBMs.

Magellan will be accepting test claims during the testing window from **August 28, 2023, through October 20, 2023**, if you would like to submit test claims, please e-mail

COVID-19 2023-2024 Vaccines

Medicaid will implement the new COVID-19 vaccines 2023-2024 on October 13, 2023 with an effective date of September 11, 2023.

Starting October 13, 2023, pharmacy claims may be submitted and reimbursed with the actual date of service from September 11, 2023 forward.
