Partners and Providers Communications Toolkit for Health Plan Enrollment

Louisiana Medicaid will include six health plans beginning January 1, 2023. The six plans are Aetna Better Health, AmeriHealth Caritas, Healthy Blue Louisiana, Humana Healthy Horizons, Louisiana Healthcare Connections and UnitedHealthcare Community Plan.

Before January 1, 2023, most Medicaid members will be auto-assigned to one of the Medicaid health plans. Medicaid members will receive a letter starting October 31, 2022, listing the member's current plan and the plan assigned to them to be effective January 1, 2023. Some members may be assigned to a health plan that is different from their current health plan; however, each member will have an opportunity to make changes.

Members can make changes to their health plan beginning November 8, 2022, to 6 p.m. March 31, 2023. Visit https://ldh.la.gov/newhealthplans to learn more.

Humana Healthy Horizons

Humana Healthy Horizons will come onboard as another MCO offering services to Medicaid recipients. The Louisiana Medicaid Pharmacy Program will now consist of Fee for Service (FFS) Medicaid and six MCOs (Aetna Better Health, AmeriHealth Caritas, Healthy Blue, Humana Healthy Horizons, Louisiana Healthcare Connections, and UnitedHealthcare Community Plan).

Humana Healthy Horizons will utilize the same Pharmacy Benefits Manager (Gainwell Technologies) as FFS Medicaid. Pharmacy claims to Humana Healthy Horizons should be submitted online at Point of Sale (POS) to Gainwell Technologies. The billing information for Humana Healthy Horizons is listed in the chart below.
