Over the last year, the NASOMH Board of Directors has been meeting regularly and working on a plan of action to grow our team, membership, and network and forge partnerships and alliances to support our mission and vision. In October, we will begin our membership blitz. We look forward to reaching out to all of you and sharing our plans for long-term engagement, growth, and sustainability of NASOMH and our membership.

In April, NASOMH held its general meeting during the Health Equity Summit in Atlanta. NASOMH had several activities at the summit, including a meet and greet for potential members and partners. We sponsored a healthy equity session that was well attended. We also held a video tapping of COVID-19 vaccine partners sharing success stories. Funding from the National Epilepsy Foundation in 2021- 2022 allowed NASOMH to partner with the organization to promote and support Seizure First Aid training and resources and train the trainer programs to interested State Offices of Minority Health (SOMH) and their community partners.

NASOMH has partnered with the Association of State and Territorial Health Officials (ASTHO) for the past few years on several initiatives, including the Power of Partnerships. This partnership includes developing resources, building networks, providing subject matter expertise, and disseminating resources and webinar opportunities to our members.

NASOMH is also a member of the States Islands and Territories Health Equity Community of Practice (SITHE-COP). With funding through William Consulting LLC provided by the Department of Health and Human Services (HHS), NASOMH's role is to render consultation and expertise to develop webinars and training on hot topics and evidence-based practices on health and health equity.
