The Louisiana Department of Health (LDH) is pleased to present its 2020 Annual Rulemaking Report, pursuant to La. R.S. 49:968K. The annual report details all of the rulemaking for each agency within LDH submitted to the *Louisiana Register* during the 2020 calendar year. There are six agencies that fall within LDH: Bureau of Health Services Financing (BHSF) a/k/a "Medicaid"; Health Standards Section (HSS); Office of Aging and Adult Services (OAAS); Office of Behavioral Health (OBH); Office for Citizens with Developmental Disabilities (OCDD); Office of Public Health (OPH), including the Bureau of Engineering Services, which is under the direction of the State Health Officer. The rulemaking for each of the six agencies within LDH is represented on the spreadsheet. All of the rules promulgated and adopted by the respective agency for the calendar year, and details the rule's name, the *Louisiana Administrative Code* citation, the *Louisiana Register* citation for the notice of intent, the date of the public hearing (if applicable), the date the second oversight report was submitted to the oversight committees, and the *Louisiana Register* citation of the publication of the final rule are noted on the spreadsheet.

LDH continues to promulgate and adopt a large volume of rules in a calendar year, due in large part to Medicaid activities. There were 61 rulemaking documents submitted to the *Louisiana Register* by Medicaid during 2020. Changing federal regulations and requirements and conditions in the healthcare field compel the Medicaid program to evolve and adjust continuously. The OAAS submitted 6 rulemaking documents to the *Louisiana Register*, the OBH submitted 7 rulemaking documents to the *Louisiana Register*, the OCDD submitted 6 rulemaking documents to the *Louisiana Register*, and the OPH 10 rulemaking documents to the *Louisiana Register* respectively.

One feature of the salient features of the 2020 annual report is the continued reduction in the number of emergency rules promulgated by the agencies within LDH. The department has made a deliberate effort to use the emergency procedure sparingly to promulgate rules.
