Evaluation of Access to Vital Records at Parish Health Units

Executive Summary

In response to Senate Concurrent Resolution 11 of the 2016 Regular Legislative Session, this report evaluates the resources needed to increase access to vital records at public health units. The report outlines two proposals that would restore public access to vital records from Parish Health Units. The first proposal would provide the public availability in each Parish, while the second proposal would provide for a geographically-distributed service center model.

As a result of the Louisiana Department of Health (LDH) (formerly DHH) budget reductions, eight LDH service centers were closed in September 2012. These service centers provided walk-in services to the public for birth and death records. Since September 2012, nine electronic kiosks have been placed in service center locations to provide citizens with increased ability to request a Louisiana birth, death, or Orleans marriage record. These kiosks are furnished by VitalChek, a third-party company, at no cost to the State of Louisiana. The customer is charged a four dollar convenience fee for placing the order through the kiosk. In addition, walk-in service for the public remains available from the Vital Records Office located in New Orleans as well as from participating Louisiana Clerks of Court.

Clerks of Court can choose to participate in vital record issuance. If a customer chooses this option, the customer is charged an additional \$19 fee. Vital Records provides each Clerk's office with banknote paper, technical support, updating of archived records, field training, and access to Louisiana Electronic Event Registration System (LEERS). Vital Records receives the same fee as the program would have received if it had been issued to the customer directly by Vital Records. Currently, there are 47 Clerk of Court locations statewide that issue birth records from LEERS (in 42 parishes). An additional 27 locations in 22 parishes currently issue death certificates (for deaths occurring since July 2012). Vital Records receives the full statutory payment for all vital records sold at these locations. Among the service center locations that were eliminated in health units, all currently have a Clerk of Court issuing records in that Parish, ensuring that access to records is maintained. The most recently added Clerk of Court is East Baton Rouge Parish in September 2016.

Budget reductions over the past six years have resulted in a reduction of staff and without additional funding it would be impossible to staff the eight service center sites that were eliminated in 2012. The restoration of vital record issuance at these sites would require two new full-time employees devoted entirely to issuance (not having any health unit duties), including salary and related benefits, at each location for a total of 16 new positions. Additional computer stations and printers would need to be purchased and devoted entirely to record issuance. Operating under the assumption that vital records are purchased as needed, these records are still being purchased through other avenues such as Clerks of Court and mail order. As a result, any expansion of walk-in services would not result in a significant increase of revenue.

Historical Parish Health Unit Vital Record Issuance

At the time of the 2012 budget reduction, there were eight health unit service centers statewide plus walk-in services at the vital records office in New Orleans. These locations were in East Baton Rouge, Tangipahoa, Lafourche, Lafayette, Calcasieu, Rapides, Ouachita, and Caddo Parishes, and the central office in Orleans Parish. In FY11, prior to the budget reduction and subsequent closure of all service centers, Jefferson Parish's service center was closed in response to a midyear budget reduction and due to its proximity to the Orleans central office location. Vital Records Service Centers issued 190,504 certified copies of birth certificates, birth cards, and death certificates during FY2012.

Above, FY16 data from Clerks of Court shows that record issuance volume remains high and comparable to the levels provided prior to the closure of the Service Centers, with the exception of Region 2 where there has been a decrease in vital records issued. Certified death certificates continue to be printed at each local Parish Health Unit for funeral homes, so Clerk of Court numbers represent reissued death certificates only. None of these locations were issuing records at the time of the Service Center closures in 2012.





Proposals to Restore Parish Health Unit Issuance of Vital Records

In response to the resolution of the Senate, this report will outline two proposals that would restore public access to vital records from Parish Health Units - one proposal for availability in each Parish and one proposal for a geographically-distributed service center model.

Option 1: Full Parish Availability - 63 Parishes (Orleans Parish excluded)

The above proposals assume hiring issuance employees at each Parish Health Unit at the Administrative Coordinator 3 level (previous service center employees ranged in level from Administrative Coordinator 3 up to Administrative Coordinator 5). The \$35,000 salary/benefit level is taken from the low end of that position's salary range. Two positions would be needed at each health unit to account for volume as well as to provide backup that would be required if either employee was on annual or sick leave. Vital record issuance would require a minimum of one dedicated computer and printer per location.

Not taken into account in these figures is the availability of a suitable location within each Parish Health Unit to serve customers, including the ability to store money, application documents (required to be retained for up to four years), and a common waiting area for customers. A review of the available facilities would need to be conducted and in some cases, remodeling of available space or identification of new space may be necessary.
