SUBJECT:	Transition of the Preadmission Screening and Resident Review (PASRR) Level I Process to Online System	

The Louisiana Department of Health (LDH), Office of Aging and Adult Services (OAAS) has selected a new partner, Maximus, for the fulfillment of **Preadmission Screening and Resident Review (PASRR)** Level I screens. OAAS announces that the PASRR Level I program will transition to the new online system for screening of individuals who are applying for admission to Medicaid-certified nursing facilities. The primary goal of the federally mandated PASRR assessment is to determine whether the nursing home is the appropriate placement for individuals with serious mental illness (SMI), intellectual disabilities (ID), or related conditions (RC). PASRR also works as a critical function to help match individuals with the care and services they need.

These planned changes to the PASRR program will go into effect on March 10, 2025. As we take steps toward this transition date, we want to ensure that you are comfortable with the updated processes and any changes to your existing role. It is also important to have accounts set up in **AssessmentPro**, the Maximus online system for assessment management, and be ready to perform PASRR-related functions.
