

The National Voter Registration Act of 1993 (NVRA) ([42 U.S.C. § 1973gg](#)), The “National Voter Registration Act”

- ✓ This legislation **requires state governments** to **facilitate voter registration** when a qualifying voter applies for or renews their driver's license or **applies for social services**;

Which Services are Required?

- ✓ Distribute the Voter Declaration Form (VRD) and the Mail Voter Registration Application Form (MVRA)

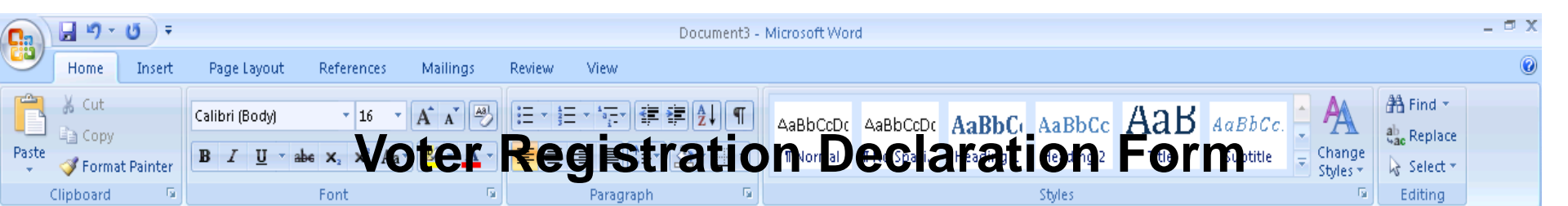

NVRA Requirements

- ✓ Reassessment of program participants
- ✓ Change of Address at any time

NVRA Requirements for Initial Applications

- The staff assisting with the application must provide the applicant with the same degree of assistance in filling out the voter registration application that he or she provides with filling out the OAAS forms, unless such assistance is refused

Forward ALL completed voter forms to OAAS

- ✓ OAAS requires that any completed forms, received by support coordinators, be submitted to the Office of Aging and Adult Services, Regional Office on a least a twice weekly basis. (Monday & Wednesday)
- ✓ OAAS Regional Offices will then scan the completed Voter Registration Form and Voter Registration Declaration form in the Electronic Consumer Record (ECR)
- ✓ OAAS Regional Offices will then forward the completed voter registration form to the Registrar of Voters office in the parish of the participant within two business days

NVRA Requirements for “Face to Face” Initial Applications

- ✓ Initial Application for services (initial determination of eligibility);
 - Face to Face Applications
 - When an applicant requests an application, the staff person conducting the application must provide the applicant with voter registration forms as part of the application packet.
 - The Voter Registration Declaration Form (VRD) and a Mail Voter Registration Application (MVRA) form shall be included
 - The Voter Registration Declaration will include the OAAS Helpline telephone number that the applicant can call if he or she needs assistance filling out the forms.

NVRA Requirements for Reassessment

✓ Reassessment of program participant

– Reassessment

- When a participant is reassessed, the staff person conducting the reassessment must provide the applicant with voter registration forms as part of the reassessment
- The Voter Registration Declaration Form (VRD) and a Mail Voter Registration Application (MVRA) form shall be included
- The Voter Registration Declaration will include the OAAS Helpline telephone number that the applicant can call if he or she needs assistance filling out the forms.

NVRA Requirements for Reassessment

- ✓ **Reassessment** for services (MDS-HC);
 - The person assisting with the application must provide the applicant with the same degree of assistance in filling out the voter registration application that he or she provides with filling out the OAAS forms, unless such assistance is refused

Forward ALL completed voter forms to OAAS

- ✓ OAAS requires that any completed forms be submitted to the Office of Aging and Adult Services, Regional Office on a least a twice weekly basis. (Monday and Wednesday)
- ✓ OAAS Regional Offices will then scan the completed forms into the Electronic Consumer Record. Retain the Voter Registration Declaration Form
- ✓ OAAS Regional Offices will then forward the completed Voter Registration Application form to the Registrar of Voters office in the parish of the participant within two business days

NVRA Requirements for Change of Address

✓ Change of Address for services

- When a change of address is received by an assessor (by phone), mail a letter confirming the address change to the applicant or recipient.
- The Voter Registration Declaration and Mail Voter Registration Application shall be included with each address confirmation letter. (The Declaration will include the OAAS helpline number)
- When a change of address is received by an assessor (in person) distribute the Voter Registration Declaration and Mail Voter Registration Application to the participant.

Forward ALL completed voter forms to OAAS

- ✓ OAAS requires that any completed forms, received by the agency, be submitted to the Office of Aging and Adult Services, Regional Office on at least a twice weekly basis. (Monday and Wednesday)
- ✓ OAAS Regional Offices will then scan forms into ECR and forward the completed voter registration form to the Registrar of Voters office in the parish of the participant within two business days
- ✓ OAAS Regional Offices will retain the Declaration form

NVRA Requirements for Change of Address

✓ Change of Address;

- The person assisting, with voter registration, must provide the applicant with the same degree of assistance in filling out the voter registration application that he or she provides with filling out the OAAS forms, unless such assistance is refused
