MEDICAID SERVICES

The search tool above will help you find medical providers that are currently active in the Louisiana Medicaid program. An “active” provider is one that has received at least one paid visit within the last six months.

Not all Medicaid providers in the list are accepting new patients. Providers have been given the opportunity to keep their new patient acceptance status up to date, but it is best to contact the provider before your first visit.

For Waiver PCA (PT-82):

- Click on Waiver Programs
- Click on Community Choices Waiver
- Scroll and click on Personal Assistance Services
- Click on Search by Region
- Click on the Region (on the map)

For an Address Change:

- First make sure you have gone through Health Standards Section (HSS).
- The main phone number for HSS 225-342-0138.
- Once you have a new license with the changed address, you will need to complete a Provider File Update Form and mail to Molina Provider Enrollment: 225-216-6370

- Go to lamedicaid.com
- On left menu, scroll down to Provider Enrollment and click
- Under “Currently Enrolled Providers” click on “Forms to Update Existing Provider Information”
- Click “here” at the bottom of the page
- Click “File Update Form”
- First page is instructions, second page is the form

If it's a main phone number change:

- Provider completes the Provider File Update Form and sends to Molina (see above)

 - The system recognizes your information as being updated when “View Info” appears **dark blue (View Info)** instead of gray (View Info).
