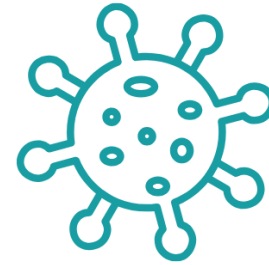

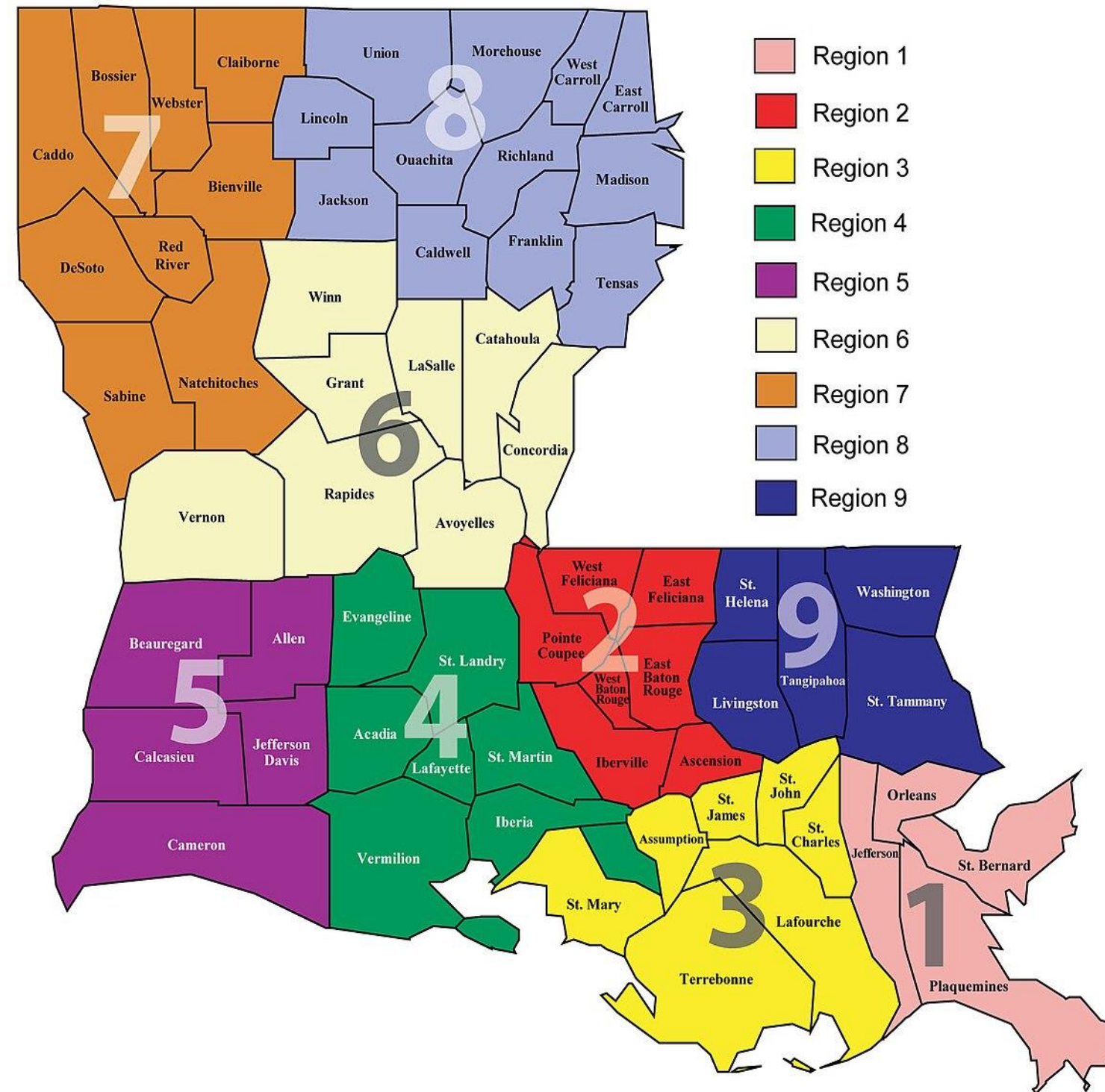

National Public Health Accreditation

To receive accreditation, a health department must undergo a rigorous, multi-faceted, peer-reviewed assessment process to ensure it meets or exceeds a set of quality standards and measures. Accreditation demonstrates that the Office of Public Health has been rigorously examined and meets or **exceeds national standards** that promote **continuous quality improvement for public health.**

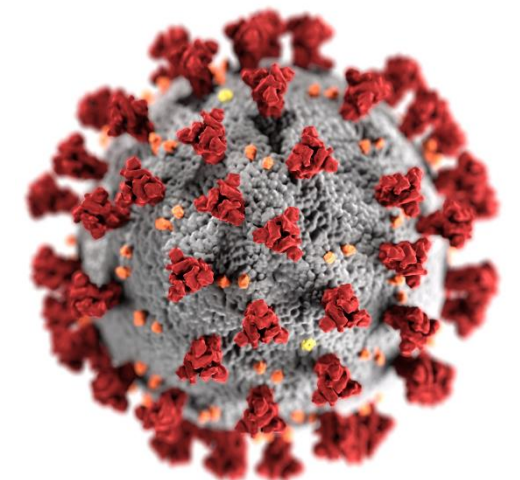

2025 PERFORMANCE

Disease Investigation and Response

- **Foodborne illness containment**
 - Epidemiologists' investigation triggered from reports of **15 cases of norovirus-like illnesses**
 - Sanitarian Services recalled roughly **18,000 sacks = 126,760 pounds of oysters**
- **ByHeart formula recall**
 - Within **2 days**, Sanitarian Services:
 - Visited **120+ retail locations** statewide
 - Identified **26 locations** with recalled product still in stock
 - Ensured the removal and destruction of **400+ units** of formula
- **Measles exposure containment (Louisiana airport)**
 - Epidemiologists conducted rapid contact tracing, monitoring, and education of exposed Louisiana residents, **limiting transmission to 3 cases**
- **Tuberculosis control (high-risk case management)**
 - Conducted **71 tuberculosis contact investigations** and **screened nearly 700 contacts**



2025 PERFORMANCE

Public Safety and Oversight

- Sanitarian Services conducted **91,000+** inspections statewide, including:
 - **Super Bowl 2025**
 - **1,487** permitted facilities identified within a mile radius of the Superdome
 - **Jazz and Heritage Festival**
 - **Inspectors visit each vendor** for proper food handling and temperatures on all food items being stored onsite
 - **Retail food establishments**
 - **80,000** annual retail food inspections

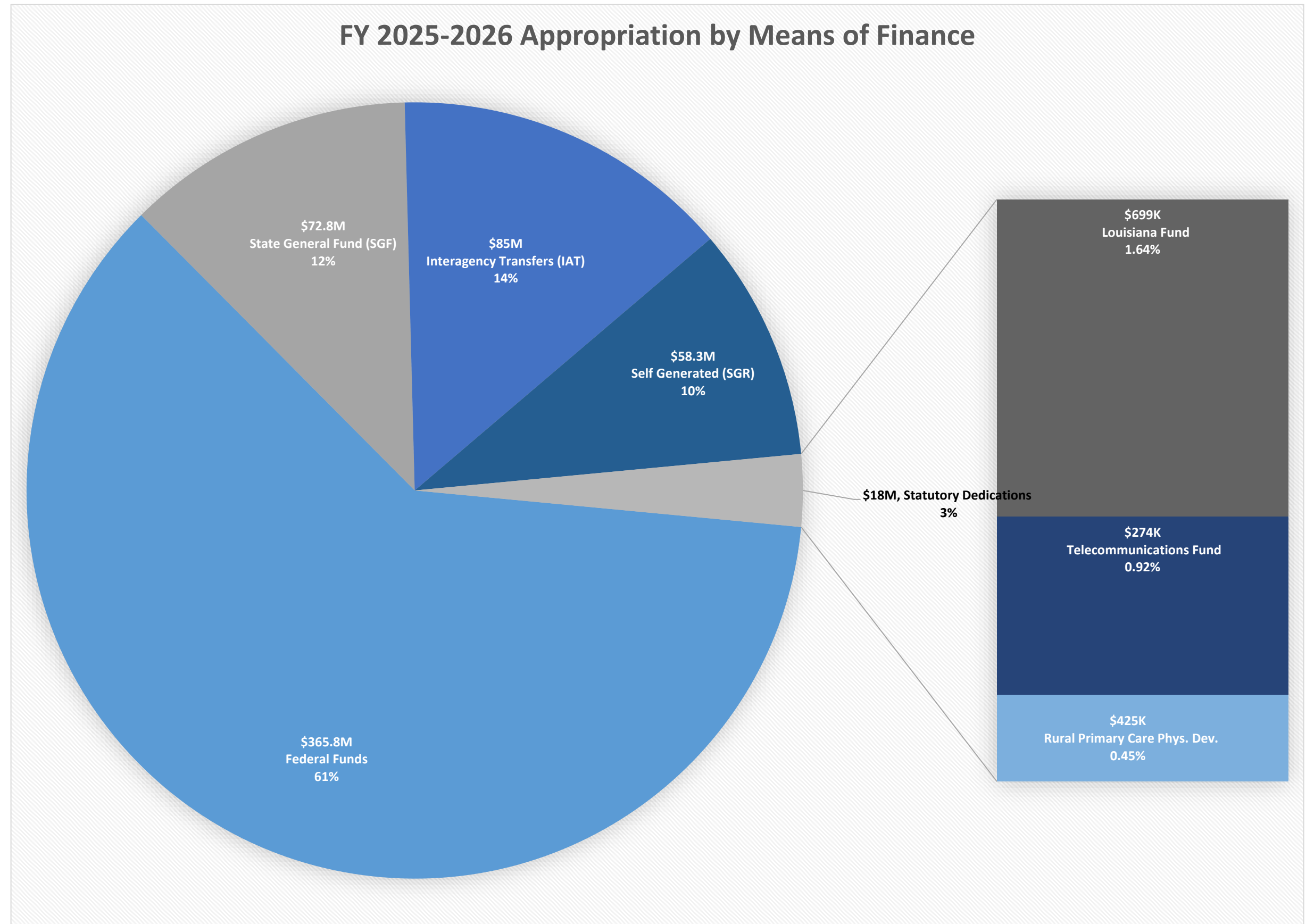

**FY26 Total Budget:
\$599.2 million**

- **Federal: 61%**
- **State General Fund: 12%**
- **Interagency Transfers: 14%**
- **Self-Generated Revenues: 10%**
- **Statutory Dedications: 3%**



FINANCIAL STEWARDSHIP

FY 26 Key Investments

- **Over \$167 million strategically invested to protect health and modernize Louisiana's public health system**
 - **\$81.3 million:** Nutrition and WIC services (maternal and child health promotion through food security)
 - **\$75.1 million:** HIV/AIDS Drug Assistance Program (insurance coverage and medication access)
 - **\$18.3 million:** Public Health IT (surveillance, reporting, and data modernization)
 - **\$23.8 million:** State Laboratory services (disease detection, water safety, newborn screening)
- **Sustained investment aligns funding with rising public health demand**
 - Expanded access to **preventive and life-saving services**
 - Improved **outbreak detection** and **faster response times**
 - Modernized **IT systems**, resulting in **improved decision-making**
 - Expanded **laboratory capacity** to support **statewide emergency readiness**
- **Funds support communities across all regions of Louisiana**
 - Resources directed toward **highest-need populations**
 - **Strong fiscal oversight and compliance** with federal requirements
 - Investments reduce **long-term health care costs** and improve **outcomes**

2026 STRATEGIES & PRIORITIES

Increase Women, Infants, and Children Program (WIC) Participation by 25% Statewide

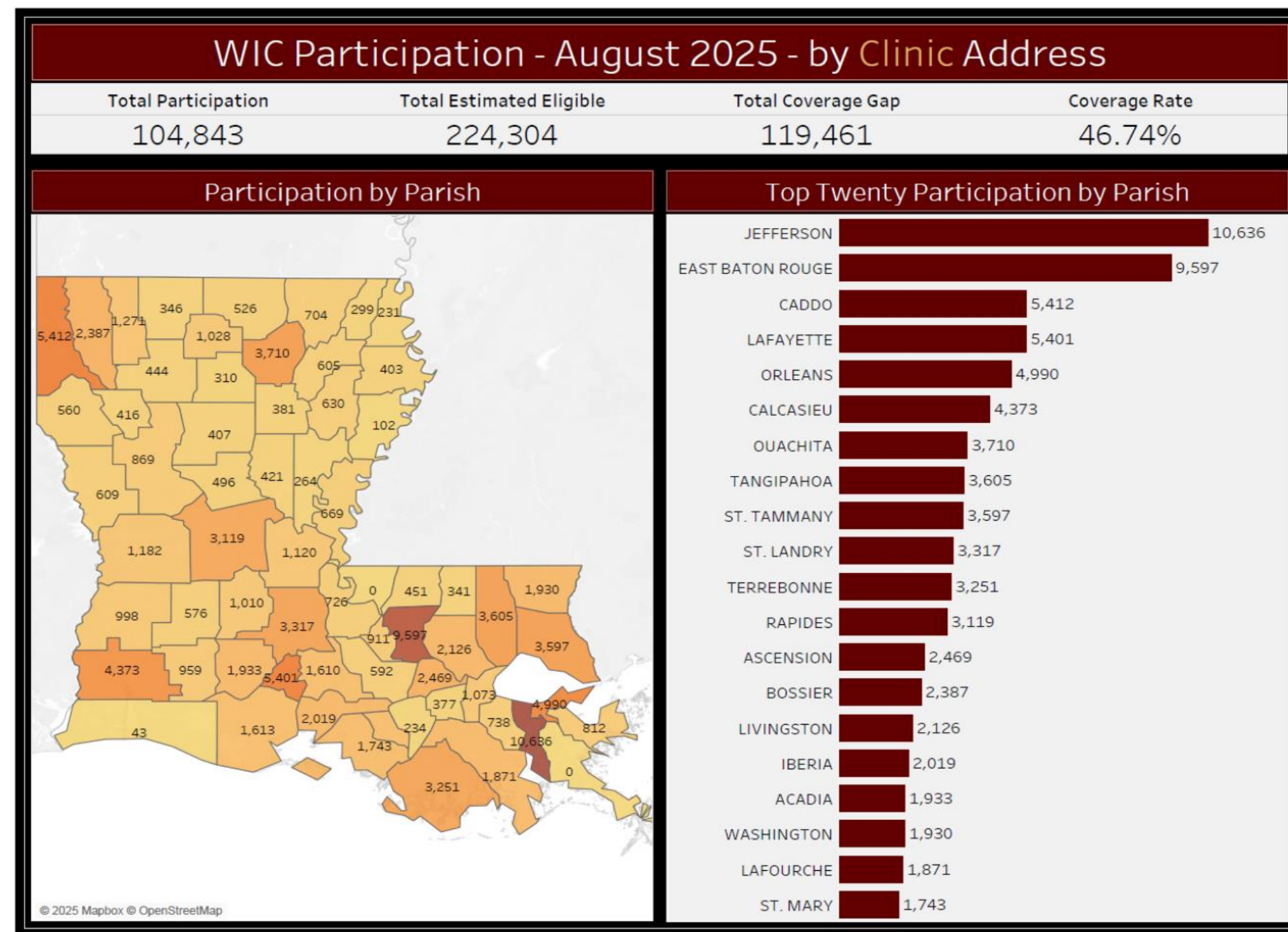
As of August 2025, Louisiana's WIC coverage rate stood at **46.74%**, with **104,843** participants out of an estimated **224,304** eligible individuals, leaving roughly **119,000** eligible individuals not enrolled. These estimates are based on Medicaid enrollees in WIC-eligible categories, including pregnant and postpartum women and children ages 0-4.

- **Barriers**

- Public misconception
- Understaffed WIC clinics
- Fixed and flat funding from the U.S. Department of Agriculture (USDA)

- **Interventions**

- Gap analysis
- New policy language
- Mobile units

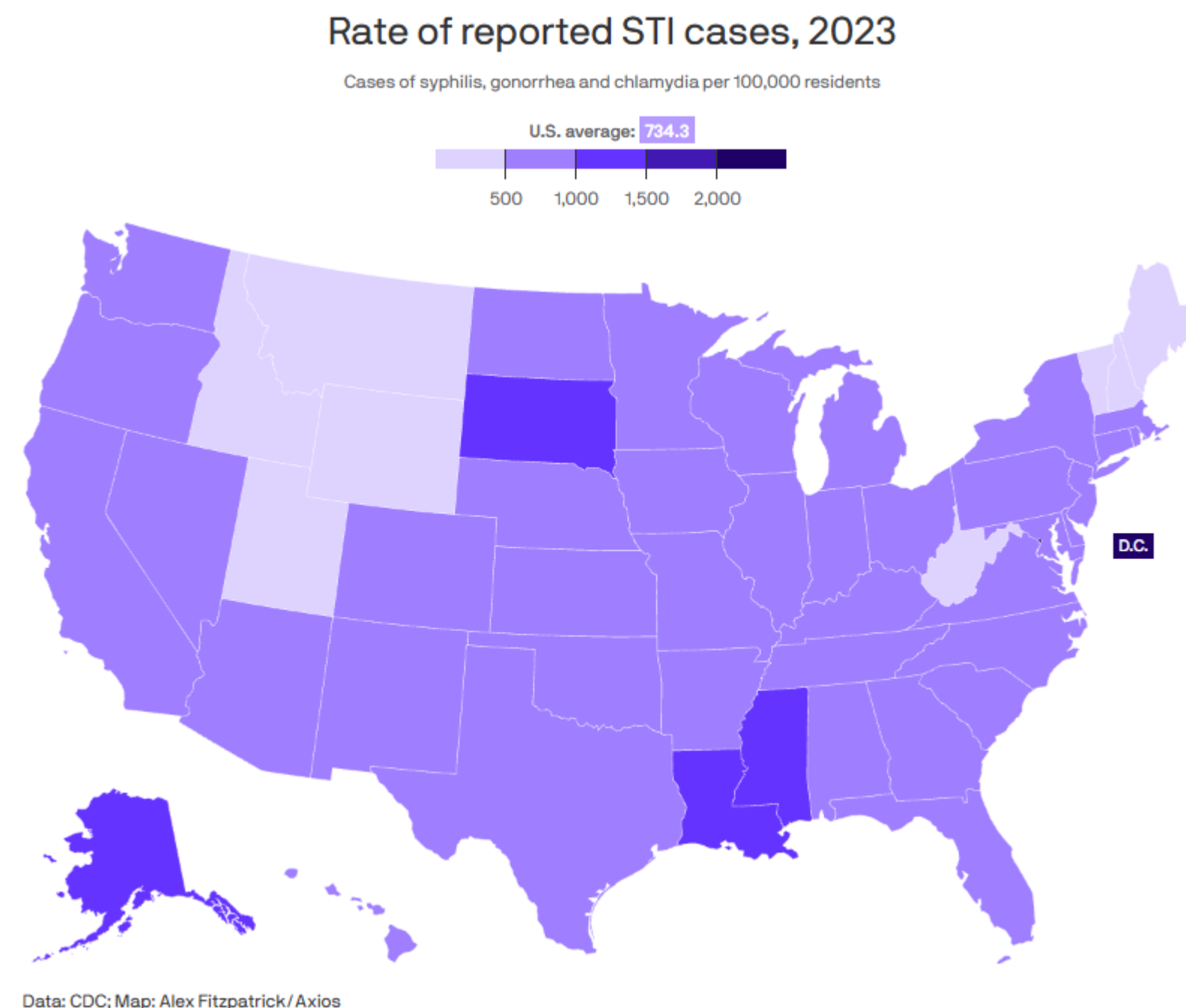
Reduce HIV and Sexually Transmitted Infection (STI) Disease Burden

- **Barriers**

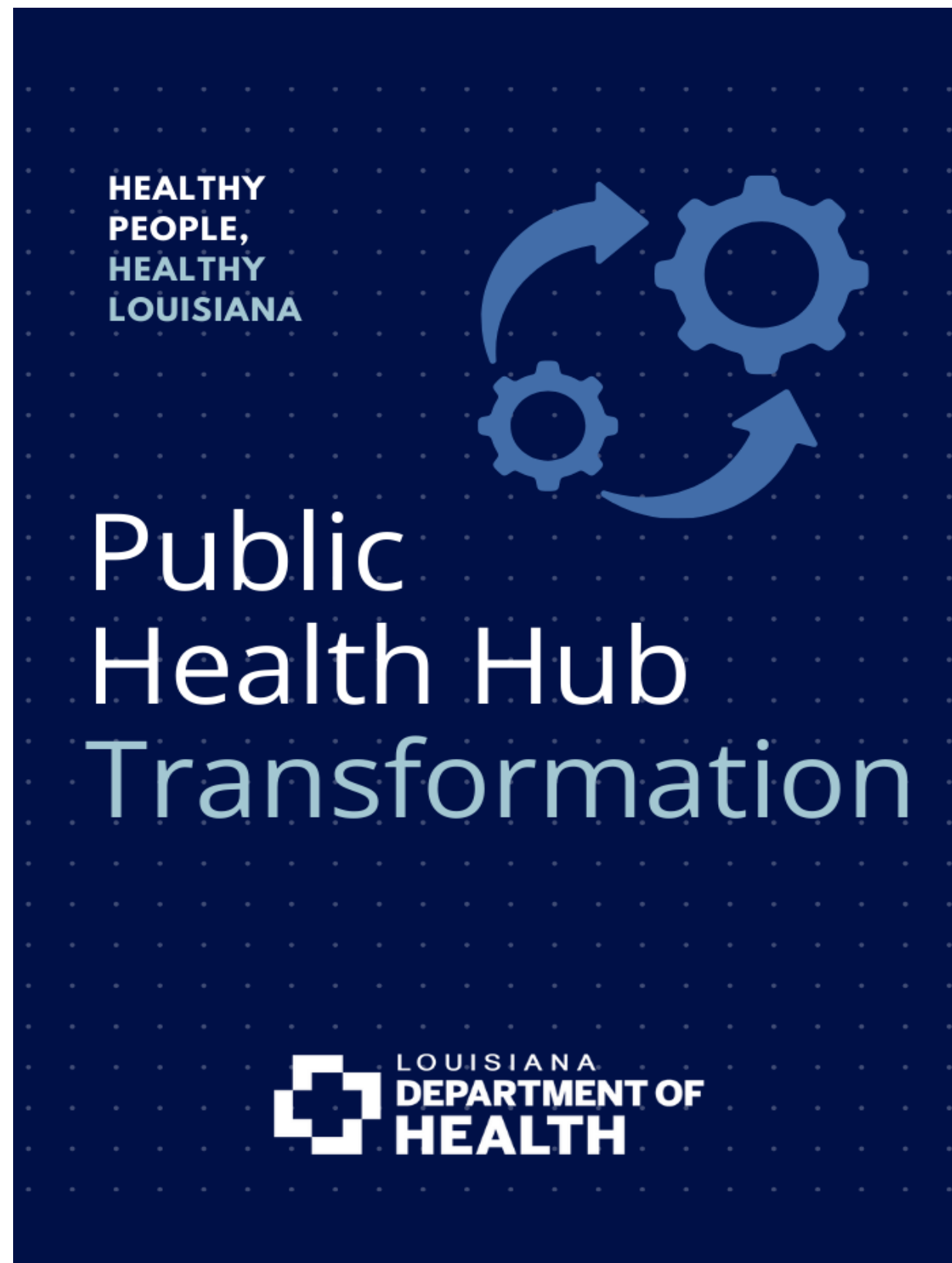
- Sexual health-related stigma
- Social determinants (poverty, health inequity)
- Stagnant federal STI funding despite increasing disease burden
- Inconsistent national screening/testing recommendations

- **Interventions**

- Targeted education (how to prevent, screen, and treat STIs)
- More testing (expanded services at parish health units, local jails, Local Governing Entities)
- Immediate linkage to care after positive test results to ensure timely treatment and reduced risk of transmission



2026 STRATEGIES & PRIORITIES



Public Health Hub Transformation

The Office of Public Health is committed to empowering our people to move from dependence to independence by **delivering the highest-quality health care infrastructure** to ensure healthier, safer lives for the people of Louisiana.

- Integrated behavioral health and case management
- Community paramedicine for treatment-in-place
- Expanded sexually transmitted infection (STI) testing and treatment
- Chronic disease screening and bridge to community care
- Tobacco cessation and health promotion
- One Door access to WIC, SNAP, and Medicaid eligibility and enrollment

2026 STRATEGIES & INTERVENTIONS

Reduce Tobacco Use Among Louisiana Youth and Adults by 3% (137,932 Fewer Adults; 32,000 Fewer Youth Tobacco Users)

Tobacco use is the **leading cause of preventable deaths** in Louisiana. **\$2.19 billion** is spent annually on smoking-related healthcare costs.

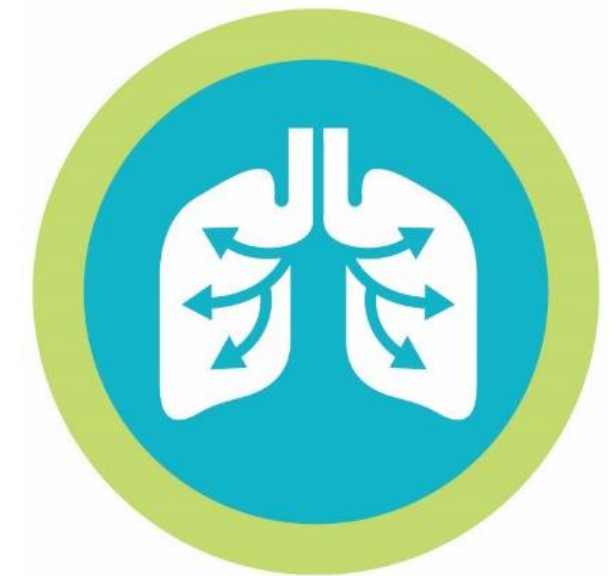
- **Barriers**

In Louisiana:

- **26%** of adults currently use tobacco (estimated **910,000** adults 18 and older)
- **13% (39,313)** middle and high school students currently vape.
- Most youth first try vapes and any tobacco at **12** or **13** years of age.
- **90%** of adult smokers started smoking before age **18**.

- **Interventions**

- Boost access to and utilization of tobacco cessation treatments by **10%**.
- Expand mass reach communication interventions to motivate quitting and prevent youth initiation by **25%**.
- Mobilize youth-led tobacco prevention education and outreach within school and community settings by **20%**.
- Enhance initiatives focused on limiting tobacco product availability and accessibility among youth by **10%**.
- Increase the implementation of comprehensive tobacco and smoke-free policies in communities and organizations of all types by **15%**.
