1. Section 2. A. i. Programmatic Requirements, Verification of Eligibility: It is unusual for any transportation provider to be allowed to request trips on behalf of a client, regardless if they are a non-profit or a for-profit. Please consider removing the last sentence of this paragraph.

It is a requirement that only non-profit providers are allowed to request trips on behalf of a client.

2. Page 4, Item 5: Please verify that this is eligibility for Medicaid services as a whole and not for NEMT eligibility.

This is eligibility for Medicaid services as a whole.

3. Page 4, Item 6: Please provide a little more detail on how Molina Information Systems interacts with the Contractor?

Molina provides a point to point contact for eligibility verification.

4. Page 4, Item 6: Please describe in more detail the "other requests for transportation" that Molina oversees.

Molina oversees the payments of the Friends and Family Program Providers and all Medicaid billing.

5. **Page 7, Section B., Deliverables:** Is the contractor only authorizing payments to providers? Who will pay the providers?

The Contractor only authorizes payments to providers and Molina will pay the providers.

6. Page 7, Section B., Deliverables: Would the DHH consider a proposal that encompasses the contractor making all NEMT provider payments and submitting a fully capitated rate cost proposal in an effort to generate a more cost efficient response from the vendors?

7. Page 9, Section 2.a. Verification of Eligibility: Item ii states the contractor is responsible for payments to the NEMT provider for any trips scheduled for ineligible persons. Is this the only payment to providers the contractor makes?

Yes

8. Page 9, Section 2.a. Verification of Eligibility: Item ii states the contractor is responsible for payments to the NEMT provider for any trips scheduled for ineligible persons, please provide data from the last fiscal year on the number of trips that the contractor or DHH was required to pay when trips were scheduled for ineligible riders.

9. Page 12-13, Section v. Reasonable Proximity and vi. Travel Over Extended Distances: Please provide a little more guidance on who is responsible for arranging and paying for out-of-area trips and other travel over extended distances.

The Louisiana Department of Health & Hospitals is responsible for arranging and paying for out of area trips and other travel over extended distances.

10. Page 13, Section vii. Capitated Rates (Standing Order) Routine Medical Treatment Scheduled Regularly: Is this section requiring the contractor pay transportation providers or friends/family members on a capitated basis for standing order trips? This is unusual and we would respectfully request that the contractor be given more freedom to pay subcontractors in the manner agreed to by both parties.

No, to both questions.

11. Page 15, Section xi. Transit Authorities: The third paragraph states that the DHH shall provide the Contractor with bus tickets. Is the DHH purchasing the bus tickets or is the Contractor expected to purchase the tickets?

Louisiana Department of Health & Hospitals purchases the tickets and then DHH Staff submits the confirmation number to the Contractor.

12. Page 16, Section viii, Assignment of Trips: Will the DHH provide the most recent contact list of NEMT providers to the vendors so they can ascertain the NEMT providers' willingness to participate in the NEMT Program and so the vendors can get an idea of current rates to ensure the most cost efficient price proposal is given to DHH?

Yes, but the Contractor does not pay the provider, the DHH does through its fiscal intermediary, Molina Information Systems, LLC.

13. Page 20, Section 3. 3. Operations Requirements a.: The first line states that scheduling services must be provided 365 days of the year, then the paragraph goes on to clarify that normal business hours are 8:00 – 5:00 Monday through Friday. Please verify that this paragraph is stating that for urgent situations (such as urgent care needs or a hospital discharge) the contractor must be available to schedule trips 24/7; however, for normal day-to-day advance reservation services, clients can only schedule these services during normal business hours.

Yes, that is correct.

14. Page 26, Section E, Subcontracting: Is DHH requiring letters of agreement be submitted through the bid process or after contract award?

Letters of agreement will not be submitted in the RFP process since subcontracting must be prior approved by the Department after the contract is awarded.

15. Page 28, Section F. 6., Subcontractor's Insurance: Please confirm this applies only to subcontractor's that provide brokered duties for a contractor and does not apply to NEMT providers.

This does not apply to Non-Emergency Medical Transportation providers.

16. **Attachment VIII, Cost and Pricing Analysis:** Is this the only sheet required for the Cost Proposal? If not, what else does DHH want submitted?

This is the only sheet that is required for the cost proposal. The Cost and Pricing Analysis is attached to the end of this document.

17. **Attachment VIII, Cost and Pricing Analysis:** This sheet only describes the total cost, and does not appear to specify if DHH wants a cost per trip or a capitated method of reimbursement. What type of reimbursement method is DHH requiring?

18. Attachment VIII, Cost and Pricing Analysis: Please provide the assumptions that the vendor is to utilize to generate costs so the DHH can compare each vendor fairly. For example, please provide the number of estimated trips if DHH wants a cost per trip to be proposed or the estimated number of eligibles if a capitated per member per month rate is expected.

See response to question #16. The estimated number of trips is not available.

General Questions

19. Is there a current vendor(s)? If so, who is it and how long have they operated the contract?

First Transit is the current Contractor and they have operated the contract since 2008.

20. Is the state anticipating awarding a single, statewide contractor or is a regional approach anticipated?

The DHH is awarding a single statewide contractor.

21. Is the state seeking an administrative broker only (an entity that takes calls, checks eligibility and prior authorizations and schedules the trips, but does not pay the providers) or a full risk transportation broker (an entity that takes calls, checks eligibility and prior authorizations and schedules the trips, and pays the providers)?

The state is seeking an administrative broker that does not pay the providers.

22. What are the minimum liability insurance requirements for NEMT providers who are approved as Medicaid Providers?

The minimum liability insurance requirement for NEMT providers is \$300,000.00 of General Liability Coverage, \$100,000 per person and \$300,000 per accident.

23. Given that the State of Louisiana has also released an RFP for Capitated Pre-Paid Health Plans that requires NEMT services be provided by the Managed Care Organizations, please describe how this contract will be affected in the future.

At this time, no dialogue has been discussed on this matter in Louisiana.

- 24. Can DHH provide a trip history (one-way trips) for a full year, if possible, or the latest few months of services:
- a. Number of trips scheduled, by region, by parish of origin.
 - No. We cannot provide trip history by region or parish of origin. 690,270. This number represents the total number of trips scheduled by region or parish of origin.
- b. Number of trips scheduled, by region, by parish of origin, and by mode of transportation (ambulatory, non-ambulatory, stretcher, bus pass, mileage reimbursement, etc.)
 - 690,270, non-ambulatory. This number represents the number of trips scheduled by region, parish of origin and by mode of transportation.
- c. Number of trips denied, by region, by parish of origin.
 - 396,152. This number represents the number of trips denied, by region, by parish of origin.
- d. Number of trips assigned to each provider, by region, by parish of origin.
 - See App. B. This number represents the number of trips assigned to each provider, by region, by parish of origin.
- e. Number of authorized bus tickets, by region, by parish of origin.
 - This information is processed by the DHH staff and authorizations are handled by DHH staff & Greyhound.
- f. Number of pending applicants who received transportation services but were subsequently declared ineligible for Medicaid, by region, by parish of origin.

- 25. Can you provide Medicaid enrollment by region, by parish, and by type (such as ABD, CFC if applicable) as of April 2011 and any projections?
 - Medicaid enrollment data is located on the DHH Website in the Medicaid Annual Reports Section.
- 26. Information given indicates that the average number of monthly calls is 65,000 70,000. Has this been consistent the past 12 months? Please confirm this is statewide. Do you have projections for monthly calls for 2011?
 - Yes, this has been consistent and these numbers are statewide. The total number of calls from January 2011-April 2011 is 323,658.

27. Can you provide call center stats, such as number of calls, call duration, percentage dropped calls for the past 12 months?

Yes, the number of calls for the last 12 months is 1,086,422 and see Appendix A for the call duration and percentage of dropped calls.

28. Can you provide monthly summary reports for the past 12 months received from the current NEMT provider by region by parish?

No

29. Can you provide completed trips by vehicle type and averages miles per trip by county or by region for the past 12 months?

33. Can you identify the number of current bus passes allotted by region by parish?

- 34. Many proposers do not fully disclose negative information which would impact their qualifications and/or the evaluation of their qualifications. Based on this, we would like to request that the RFP be amended to require proposers to fully disclose certain serious negative contract problems, for themselves as well as their principles and affiliates, at least for contracts or potential contracts in the last seven years, which we feel should include at a minimum:
 - Any investigative or audit or similar findings or charges of proposer or proposal principle's fraud, malfeasance, anti-trust violation, civil violation, violation of transportation regulations, criminal activity or fine including those agreed to by settlement;
 - b. Contracts with any formal cure notices to cure or formal audit findings concerning contractor deficiencies;
 - c. Contracts concluded prior to expiration by termination, negotiation or settlement;
 - d. Contracts terminated for convenience either by the contractor or at the contractor's request;

- e. Contracts where the contractor requested that option periods not be exercised, excepting options periods that required mutual agreement;
- f. Contracts where costs were renegotiated during the contract term at contractor's bequest.
- g. Detailed information on all proposer lawsuits for issues pertaining to contract performance, payments, or other obligations under the prime contract agreement or under agreements to transportation subcontractors.

DHH will not revise its RFP as requested; DHH is satisfied with the RFP as written.

35. According to the "Schedule of Events" on page 6, the contract negotiations begin May 31, 2011 and the contract start date is July 1, 2011. Is the contract start date the same as the service go live? If so, this does not leave sufficient time for implementation that would include infrastructure build out and hiring/training of staff. Any consideration for a different timetable?

36. Under the "Statement of Work" on page 7, the first sentence of the third paragraph states, "Through this RFP, the Department intends to contract for management of a transportation provider enrolled in the Medicaid Program." Can you please clarify this statement? Should that have said "... intends to contract for management of transportation providers enrolled..."?

According to the Statement of Work on Page 7, the Contractor will manage and oversee the operations of transportation providers providing non-emergency medical transportation.

37. Under the "Deliverables" listed on page 7, (2) verification of client eligibility, how often does member eligibility information change in Louisiana? Will the Department consider providing the Contractor with a recurring (daily, weekly, or monthly) file of eligible members that the Contractor can import into their software system?

According to Deliverables listed on page 7, member eligibility changes annually. However, if interim changes occur, the Contractor will be notified of the changes.

38. If non-profit providers are allowed to call the contractor to request trips for recipients, the gate keeping functions cannot be performed with the recipients to determine appropriateness of the trip. How does the current contractor overcome this barrier?

According to the gate keeping functions, presently, the current Contractor is not inundated with many of these calls because the calls are limited in nature. Most non-profits fill out a request and email it in.

39. Are recipients in the "Service Limited Medicare Beneficiary (SLMB)" category not eligible for transportation?

Some recipients in the Service Limited Medicare Beneficiary (SLMB) category qualify for medical transportation.

40. Does the Contractor issue one authorization number (PA number) for a round trip or two PA numbers? Will the Department supply the first, or initial, number that the contractor should use for the first authorized trip? Is the PA number numeric only or alphanumeric?

The Contractor issues one PA number for a round trip. The Contractor supplies the number the provider must use. The first letters of the PA number is alphanumeric and the remaining numbers are numeric.

41. On page 10, iv of the RFP it states, "If the Contractor schedules transportation for a Medicaid applicant in pending status and the application is ultimately denied, the Contractor is responsible for the provider payment. However, this is a rare occurrence." How quickly will the state provide information on Medicaid applicants and their status in order for the Contractor to understand its exposure to the denial payment obligation? Can "rare occurrence" be defined and historical data on pending/denials provided?

The Contractor will not schedule transportation for a Medicaid applicant in pending status. The State can provide information on Medicaid applicants within days. There has only been one occasion in May, 2010 whereby the Contractor was responsible for the provider payment of denied payments.

42. Is there any circumstance where the recipient has a medically necessary appointment following a routine appointment that can be authorized and covered on the same day?

Yes

43. In the first paragraph on page 12, the RFP states. "...The provider may refuse to transport the recipient, or may refuse to transport more than one attendant per recipient." <u>Is this accurate?</u> Are there any restrictions or limits on how many times a transportation provider can refuse to take a trip?

Yes this is accurate. There are no restrictions or limits on how many times a transportation provider can refuse to take a trip but DHH monitors the number of refusals and takes further actions in these cases.

44. Assignment of Trips – In what format does the DHH provide the "enrolled NEMT provider list" with the updated list?

The Contractor provides the assignment of trips in PDF format via a fax modem system called blast fax.

45. Under the "Second Trips on Same Day" section on page 16 of the RFP it states, "...and there is sufficient time between the first and the second appointment to justify a return trip to the home of the recipient." Can you define "sufficient time"?

Sufficient time depends on the distance of the trip and the amount of time it takes to transport the client home.

46. What differentiates an "urgent" complaint from an "emergency" complaint?

An urgent complaint must be responded to within 10 days of receipt. An emergency complaint must be responded to within 48 hours of receipt. The urgent complaint is non-life threatening and can be answered within a specified time frame. An emergency complaint is life threatening and may require additional assistance from DHH administration.

47. If the Contractor develops an action plan that requires the provider to address poor performance (such as on time pick up) will the broker be empowered to enforce that action plan by reducing or eliminating trip assignments to the transportation provider for non-compliance? How are these action plans currently managed?

Yes. The current Contractor lowers the number of rides of the transporter involved in the poor performance.

48. What is the "procedure code" and who provides it?

The procedure code is the code that the NEMT providers use to bill for payment for services rendered through the fiscal intermediary. DHH provides the procedure codes.

49. On page 19, section iii, it specifies the Contractor shall submit a monthly back-up tape to DHH. What type and format of tape is DHH referring? There are various types and formats of back-up tapes and often tapes from one device cannot be read on other devices.

The current Contractor backs up the information to its server nightly. The information is backed up to another computer in synced format. The DHH and the selected Contractor will negotiate on the format the new Contractor will use to back up data.

50. On page 8, General Requirements, section g, it states the program documents must be retained in the Contractor's central office location. On page 22, section d – Office Location, it states, DHH will only allow one location. Is it the intent of DHH to have one central office/call center in the state?

DHH will allow only one site for a Contractor. Contractor must have a dispatch office within the State of Louisiana. The purpose is for the Contractor to have a physical presence within the state for conducting business with Medicaid enrollees, transportation providers, and NEMT Program Office staff. This will also enable the Contractor to perform these contract requirements:

Participate in hearings requested by recipients when issues involve the Contractor, as
determined by the Department of Health and Hospitals, NEMT Program Office.
Hearings shall be conducted in accordance with guidelines, rules, and regulations
established by the Rules of the Louisiana Division of Administrative Law.

- Attend and prepare documentation for fair hearings, appeals, and related meetings, at no cost to the Department of Health and Hospitals, NEMT Program Office.
- Agree to make its employees available as witnesses, without charge, for the state Attorney General Medicaid Fraud Control Unit, and to the Department of Health and Hospitals, NEMT Program Office.
- Provide documentation for all enforcement proceedings and hearings.
- 51. If the state is securing all of the transportation provider contracts and the contracts are between the state and these companies, why does the Contractor need to secure Automobile Liability Insurance?

The Contractor must secure automobile insurance for its employees. DHH wants to ensure that employees of the contractor are insured if they for any reason would have to travel within the scope of their work.

52. Contractual Information mentions Attachments I through VIII. The document only appears to include up to Attachment IV. A search of the procurement site does not seem to show Attachments V through VIII. Can the Department direct us to the location of those attachments?

Attachments V-VIII are attached to the end of this document.

53. Are trips to the emergency room allowed under this contract?

Trips are not allowed to the emergency room under this contract.

54. Is it the responsibility of the Contractor to manage "Where's My Ride" calls?

Yes

55. Is it the plan of DHH to open bids on the due date?

No, the Department will not open bids the day after the deadline of the proposals. This procurement is not under the Procurement Code. Bids are not made; proposals are submitted which will be reviewed and evaluated before an award is made.

56. Can the state provide any data to help the bidders calculate the most attractive pricing? For example, annual number of calls, current staffing levels in call center, etc.

57. Since the contractor is responsible for determining the appropriate level of service for the beneficiary it is possible that the State has not contracted for this service or the capacity is fully utilized. What are the proper procedures for the situation where the appropriate level of service (e.g., wheelchair van) is not available?

The Department will explore additional levels of service and provide other means of transportation to Medicaid clients in the event transportation is not available.

58. Will DHH provide additional data/information about trip and call volume?

59. Is there any responsibility for recovering Cap Rate dollars paid to a for-profit transportation provider if it is uncovered that a member's schedule or attendance was reduced from 5 to 4 days a week or 4 days to 3 days a week schedule after the provider had already been paid?

The fiscal intermediary, Molina Information Systems, LLC, and the Program Integrity Section of the Department of Health & Hospitals works in concert with the NEMT Contractor to recoup for capitated trips being reduced.

- 60. Are there any exceptions (special negotiated rates) to the NEMT rates paid to providers?

 Does the agency ever pay reimbursement to any taxi providers based on their metered rates?
 - 1. Yes. 2. The Department, at present, does not reimburse taxi providers based on their metered rates.
- 61. Is the Agency looking at an administrative flat fee for the year to be paid out monthly? Would the Agency consider different pricing proposal dictated on the volume of calls and/or trips handled?
 - 1. Presently, the Department pays monthly contract payments to the NEMT Contractor which includes an administrative flat fee. 2. The Department is not considering different pricing proposal dictated on the volume of calls and/or trips handled.
- 62. How will this RFP and trip and call volume be affected by the managed care phasing in that the Agency is undertaking over the next two years? Is the current volume expected to be decreased significantly?

Presently, the RFP and trip/call volume will not be affected by the Managed Care phasing in that the Department is implementing because the Managed Care Phasing in is still in the early stages of development. The current call volume cannot be determined at this time as it relates to the Managed Care Phasing in Program.



Attached is a sample of the Transportation PA Form that will be generated on a daily basis by the Transportation PA Schedulers and mailed to the designated Family & Friends Providers. They in turn will provide the prior authorization service, sign and date the PA Form before returning it to Unisys.

At this point the form will be assigned an ICN, microfilmed, and key entered as Transportation Claim which will then be subjected to daily and weekly claim edits. Checks and Remittance Advices will be generated to the Family and Friends Providers for all adjudicated claims on a weekly basis.

The PA Process exists today for all Profit and Non-Profit Providers will remain in place.

BATCH FILE PROCESSING

The following batch processing edits will be performed on the TRANSPORTATION PA TRANSACTION FILE prior to MMIS Daily Claim Processing, scheduled for Tuesday, Wednesday, and Thursday nights. All valid entries will update the Transportation PA Master File and erroneous entries will be generated to a file in the same format as the PA Transaction File received from the submitters with associated error codes attached, up to a maximum of five. This file will be made available for dialup by the appropriate submitters. The invalid entries can then be corrected and resubmitted with the following day's transactions.


