CODE	REASON FOR DENIAL
N01	Countable Income exceeds Title XVI federal benefit rate
N02	Recipient is inmate of public institution
N03	Recipient is outside of the U.S.
N04	Non-excludable resources exceed Title XVI limitations
N05	Unable to determine if eligibility exists
N06	Failed to file for other benefits
N07	Cessation of Disability
N08	Cessation of Blindness
N09	Refused vocational rehabilitation without good cause
N12	Voluntarily withdrew from program
N13	Not a citizen or eligible alien
N14	Aged claim denied for age
N15	Applicant not Blind
N16	Applicant not Disabled
N17	Failure to pursue claim by applicant
N18	Failure to cooperate
N19	Voluntarily terminated participation in the SSI program
N20	Failure to provide required report
N22	Inmate of a penal institution
N23	Not a U.S. resident
N24	Penalty imposed – claimant provided false or misleading statements to obtain benefits
N25	Claimant is fleeing to avoid prosecution for, or custody or confinement after conviction for, a crime which is a felony under the laws of the place from which he/she flees, or is violation a condition of probation imposed under Federal or State law
N27	Disability terminated due to a substantial gainful activity
N30	Slight impairment, no visual impairment
N31	Capacity for substantial gainful activity – customary past work; no visual impairment
N32	Capacity for substantial gainful activity – other work; no visual impairment

CODE	REASON FOR DENIAL
N33	Engaging in substantial gainful activity despite impairment, no visual impairment
N34	Child under age 18, impairment(s) disabling for a period of less than 12 months
N35	Impairment severe at time of adjudication but not expected to last twelve months, no visual impairment
N36	Insufficient or no medical data furnished
N37	Failure or refusal to submit to consultative examination
N38	Applicant does not want to continue development of the claim
N39	Applicant willfully fails to follow prescribed treatment
N40	Impairment(s) does not meet or equal listing (disabled child under age 18 only), no visual impairment
N41	Slight impairment - medical condition alone, visual impairment
N42	Capacity for SGA – customary work, visual impairment
N43	Capacity for SGA and other work, visual impairment
N44	Before 3/9/91: Engaging in SGA despite visual impairment; Effective 3/9/91 Child under 18. Impairment not severe
N45	Visual impairment did not last 12 months
N46	Visual impairment not expected to last 12 months
N47	Insufficient, or no medical evidence furnished, visual impairment
N48	Failure or refusal to submit to consultative examination, visual impairment
N49	Applicant does not want to continue claim, visual impairment
N50	Applicant willful fails to follow prescribed treatment, visual impairment
N51	Impairment does not meet listing
N52	Deleted from the State rolls before 1/73 payment
