Call to Order

Ms. Wendt announced that the Chairman and Vice-Chairman were unable to attend the meeting. Dr. Vanessa De La Cruz volunteered to Chair the meeting. She called the meeting to order at or around 9:37 am CT.

- A. Introduction of Members/Roll Call. Dr. De La Cruz asked P&T Committee members, LDH staff, and Prime staff to introduce themselves.
- **B.** Approval of October 30, 2024 Meeting Minutes. Dr. De La Cruz indicated the members cannot vote on approval of the Minutes due to not having quorum.

Ethics

Ms. Williams presented the code of governmental ethics for the P&T committee members. She indicated they set forth objective standards of conduct to protect public confidence in the integrity of government by ensuring public servants remain independent and impartial, decisions and policy are made in the proper channel, and public positions are not used for private gain.

Reports

Ms. Wendt informed the P&T Committee members that LA currently participates in the TOP\$ pool to maximize supplemental rebates. She also noted that in the past they had a separate contract with Asegua on a Hepatitis C Agent, Ledipasvir/Sofosbuvir (generic EPCLUSA). They will have completed the 6th year at the end of June and will start one more year with generic EPCLUSA being the preferred agent for the next fiscal year.

Public Testimony

Ms. Douiki asked that any member of the public who wished to provide testimony to wait until their therapeutic class is reviewed and then raise their hand once the Chair asks if there is any public testimony. Once the testimony is started, a timer will be placed on the screen. She kindly asked that any speaker who has signed up to provide testimony and their drug is preferred, to give their time back.

Ms. Douiki provided an overview of the TOP\$ supplemental rebate pool that Louisiana Medicaid participates in. She presented information about clinical and financial components of the recommendation process. She also summarized the supplemental rebate process. She indicated to the members that they should have received clinical documents, in the form of Therapeutic Class Reviews or New Drug Updates...etc. The committee members should also have cost sheets which include relative values, rather than actual numbers, in order to comply with the privacy laws regarding rebates.
