Overview			

This document addresses the use of Sylvant (siltuximab). Sylvant is a monoclonal antibody which binds to interleukin-6 (IL-6) receptors and inhibits release of proinflammatory cytokines. It is primarily used to treat multicentric Castleman's disease.

The FDA approved indications for Sylvant include treatment of multicentric Castleman's disease in individuals who are human immunodeficiency virus (HIV) negative and human herpesvirus-8 (HHV-8) negative. Sylvant has a labeled warning that it should not be administered to individuals with severe infections.

The National Comprehensive Cancer Network[®] (NCCN) provides additional recommendations with a category 2A level of evidence for the use of Sylvant in relapsed or refractory, surgically unresectable unicentric Castleman's disease. NCCN guidelines for management of immunotherapy-related toxicities to include the use of siltuximab as an option for chimeric antigen receptor (CAR) T-cell related cytokine release syndrome refractory to high-dose corticosteroids and anti-IL-6 therapy.

Definitions and Measures

Castleman's disease (CD): A rare, non-cancerous disorder that affects the lymph nodes and other immune-cell structures throughout the body. CD has two variants: unicentric CD and multicentric Castleman's disease and is also known as giant lymph node hyperplasia and angiofollicular lymph node hyperplasia.

Clinical Criteria

 Sylvant (siltuximab) used as a single agent; AND
- VII. Individual is Human immunodeficiency virus negative; AND
- VIII. Individual is Human herpes-8 negative; AND

 IX.
 Individual has a diagnosis of Grade 4 chimeric antigen receptor (CAR) T cell-induced CRS (NCCN 2A);
 AND

 VI-X.
 CRS is refractory to high-dose corticosteroids and other anti-IL-6 therapy.
