Request for Tribal Comments

17-0014 Inpatient Hospital Services – Graduate Medical Education - Supplemental Payments Pool Elimination

Effective date March 1, 2017

The purpose of this SPA is to eliminate the total supplemental payments pool for graduate medical education payments to qualifying acute care hospitals.

17-0015 Inpatient Hospital Services - High Medicaid Hospitals - Supplemental Payments Pool Reduction

Effective date March 1, 2017

The purpose of this SPA is to reduce the total supplemental payments pool for non-rural, non-state hospitals classified as high Medicaid hospitals.
