## Federally Qualified Health Centers – Alternative Payment Methodology Effective date: April 1, 2019

The purpose of this SPA is to amend the provisions governing the reimbursement methodology for Federally Qualified Health Centers (FQHCs) in order to implement an alternative payment methodology to allow FQHCs to be reimbursed a separate perspective payment system (PPS) rate for behavioral health and dental services, which is at the same rate as the existing all-inclusive encounter PPS rate when such services are rendered on the same day as a medical visit.

# Rural Health Clinics – Alternative Payment Methodology Effective date: April 1, 2019

The purpose of this SPA is to amend the provisions governing the reimbursement methodology for Rural Health Clinics (RHCs) in order to implement an alternative payment methodology to allow RHCs to be reimbursed a separate perspective payment system (PPS) rate for behavioral health and dental services, which is at the same rate as the existing all-inclusive encounter PPS rate when such services are rendered on the same day as a medical visit.

### School-Based Health Services Effective date: March 20, 2019

The purpose of this SPA is to amend the provisions governing school-based medical services covered in the Early and Periodic Screening, Diagnosis and Treatment (EPSDT) Program and school-based behavioral health services in order to: 1) add services categorized as 504 plans, individual health plans or otherwise medically necessary in addition to those covered by an individual education plan, to the services available for school-based Medicaid claiming; 2) amend the reimbursement methodology to expand allowable billing providers for direct/therapy and nursing services; and 3) add applied behavioral analysis, personal care services and transportation to allowable Medicaid billing.
