State Plan Amendment for Submittal to CMS
Request for Tribal Comments
February 1, 2021

Intermediate Care Facilities for Individuals with Intellectual Disabilities
Effective date: February 2, 2021

The purpose of this SPA is to revise provisions governing the temporary rates for intermediate care facilities for persons with intellectual disabilities (ICFs/IID) that have a cooperative endeavor agreement with the Office for Citizens with Developmental Disabilities and have a high concentration of people who have intellectual/developmental disabilities, significant behavioral health needs, and high risk behavior resulting in previous interface with the judicial system, and for whom no other private ICFs/IID provider is able to support.
