State Plan Amendment for Submittal to CMS

Mandatory Medicaid State Plan Coverage of Medication-Assisted Treatment
Effective date: October 1, 2020

The purpose of this SPA is to comply with Section 1006(b) of the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment (SUPPORT) for Patients and Communities Act and State Health Official (SHO) Letter #20-005, by continuing access to medication-assisted treatment (MAT) for opioid use disorders (OUD) through Medicaid coverage of certain drugs and biological products and related counseling services and behavioral therapy.
