## LA SPA TN 23-0021

**COVID-19 Update:** Changes to Medicaid policy and procedure deemed of an imminent peril to the public health, safety, or welfare and requiring immediate approval, *such as those related to COVID-19*, are exempt from the legislative requirement to publish the proposed policy or procedure for public comment prior to implementation.
