Request for Tribal Comments June 17, 2025

CHIP Section 5121 Services to Incarcerated Youth Effective date: January 1, 2025

The purpose of this SPA is to implement required coverage for incarcerated youth in Medicaid and the Children's Health Insurance Program (CHIP), as described in section 5121 of the Consolidated Appropriations Act, 2023 (CAA, 2023). Within the 30 days prior to release (or within one week of release, or as soon as practicable after release), the State will provide eligible children with any screenings, diagnostic services, or case management services that would otherwise be available to children under the CHIP State Plan (or waiver of such plan).

CHIP Substitution of Coverage Effective date: June 3, 2025

The purpose of this SPA is to amend the provisions governing the Children's Health Insurance Program (CHIP) in order to remove the waiting period for those beneficiaries who had private insurance within the 90 days prior to application. This change is in accordance with CMS Final Rule <u>89 FR 22780</u>.
