# TANF Match Interface

---

## *Overview*

---

OFS is required to match TANF (Temporary Assistance for Needy Families) closures against MEDS data four months following the closure to determine if the person is eligible for Medicaid. The TANF Match Interface receives a file of these closures from OFS, determines eligibility in the month requested and reports the result back to OFS.

## TANF Match Interface

---

The TANF Match process reads each record on the input file from OFS and determines eligibility for the person for the input month.

### TANF Match Process (MEITNFZ)

#### Initial Processing

Call the Run Control object subprogram with the Next-run-number function for the 'TANF Match interface' process (proc id TANFMTCH). Move the run number that is returned to the run number local variable.

#### Mainline processing

Read the input work file

Perform data validations of the LAMI CID, PID, SSN and Month of Inquiry

If invalid data found

Report this as an exception

Escape Top /\* process next record

End if

Find ME-PERSON with LAMI PID from the work file.

Read AU Member by Person, Start Date 9C starting from End of Inquiry Month 9C

If AU Member Person Number > ME-PERSON Person Number

Escape bottom

End If

Reject cancelled future eligible AU Members

Reject if closed or suspended before last day of inquiry month

Assign Eligibility Indicator = "Y"

Escape bottom /\* find

End Read

End Find

If a match was found and Eligibility Indicator not = "Y"

Report this as an exception

End If

If no exact match is found

Set Error Indicator to 'E' /\* PID not found in MEDS

Report this as an exception

End If

Write output work file

Report all exceptions that occur on an exception report and continue processing.

End Read

At end of process

Call the Run control object subprogram to complete the transaction.

Write a control report of program statistics: TANF records read, Errors found, eligible records, ineligible records and TANF record with no match in MEDS.

Call the Run control object subprogram to complete the transaction.
