Re: Regulatory Updates to Align with ASAM 4th Edition

MEMORANDUM

This memorandum serves to advise behavioral health service providers (BHSPs) regarding recent changes to the LAC 48:1.Chapters 56 and 57, Behavioral Health Service Providers Licensing Standards. Chapters 56 and 57 previously reflected the adoption of the American Society of Addiction Medicine (ASAM) 3rd Edition criteria for minimum staffing, service provisions, and other practice standards. On September 20, 2025, the Office of the State Register (OSR) published a Notice of Intent in the *Louisiana Register*, advertising rulemaking activity of the Louisiana Department of Health (LDH), Health Standards Section (HSS). In the Notice of Intent HSS proposed, in part, to update its rules to align with the updated criteria as published in the ASAM 4th Edition. Rulemaking was completed with the final rule publication in the *Louisiana Register* on January 20, 2026.

All BHSPs shall be required to be in compliance with the updated regulations no later than July 1, 2026. The current rules have been posted to the HSS BHSP webpage, <https://ldh.la.gov/health-standards-section/behavioral-health-service-provider>. An updated licensure application is also located on the web page. Any changes required to a BHSPs' license as a result of the updated regulatory criteria, shall be made at the time of annual license renewal or other licensing transaction.
