Overview of Cost Reporting Refinement Initiative

Purpose of Project

Refine and streamline the cost reporting tools used to collect required data from Medicaid-funded home- and community-based services (HCBS) and Adult Day Health Care (ADHC) providers to:

- Support data accuracy and completeness
- Streamline tools to improve usability and accessibility for providers
- Reduce provider and LDH administrative burden
- Collect data that can help inform potential future payment rate updates and funding considerations
- Collect data to support compliance with state and federal requirements regarding direct/clinical care worker compensation

LDH anticipates using the updated tools for use in reporting due in 2026.

This project does not change cost reporting requirements effective in 2025; providers must complete the current cost reporting templates by the required due dates.

Anticipated Timing and Feedback Opportunities

Provider Meetings

Oct – Dec 2025

- Conduct all-provider meeting
- Conduct provider workgroups
 - **Four workgroups:** Large providers, small/medium providers, ADHCs, support coordinators
 - **Identification of workgroup members:** Based on prior participation in rate study workgroups and size/type
 - **Workgroup member role:** Provide feedback on draft tools and participate in the piloting of the draft tools

Pilot Group

Jan – Feb 2026

- Conduct a pilot of the updated cost reporting tools, specifically:
 - Test the updated tools across key provider types
 - Gather feedback on usability, clarity, and overall effectiveness of the tools
 - Use feedback to inform final revisions to the tools and processes

Review and Distribution of Final Tools

Feb – April 2026

- Incorporate final revisions to the cost reporting tools
- Share updated tools with all providers

Initial Considerations for Changes



Consideration for Variability in Tools

- **HCBS cost reporting templates:** Provide small/medium providers the option of completing a more streamlined tool as compared to large providers
- **ADHC cost reporting template:** Make targeted adjustments



Areas of Improvement Identified to Date

- Simplified data entry fields / consolidation of line items
- Clear definitions and examples of cost categories
- Automated checks for common errors and missing information

Note: Due to state and federal requirements, there will continue to be a focus on reporting of direct / clinical care staff compensation.





Feedback on Current Cost Reporting Approach

High Level Summary of Feedback Received to Date

- Cost report is time consuming and requires a specific set of expertise in accounting to complete accurately
- Cost report expense categories can be challenging to align with provider internal financial documents
- Manual entries are required throughout current cost report adding additional complexity
- Terminology in cost report is sometimes confusing, need for plain language
- Specific to support coordination, there is some duplication between the cost report structure and the requirement to have audited financials.
- Need for additional technical assistance, including training, instruction materials, and support
- Uncertainty regarding whether current cost report submissions are being effectively utilized, including for purposes such as rate increases
