

APPROVED DAVIS BACON and RELATED ACTS (DBRA) ADMIN. CONSULTANTS / LABOR COMPLIANCE OFFICERS

As part of the Engineering Contract, the Loan Applicant or its Consultant Engineer is responsible for selecting and hiring a Davis Bacon and Related Acts (DBRA) Administrative Consultant to serve as the project's 'Labor Compliance Officer'. DBRA, enacted by the United States Congress, cover contracts that are federally funded. ALL contractors and sub-contractors for DWRLF-funded projects are required to comply with DBRA, which includes the Davis Bacon Act, the Fair Labor Standards Act, Contract Work Hours and Safety Standards Act, Copeland "Anti-Kickback" Act, Walsh-Healy Public Contracts Act, and McNamara-O'Hara Service Contract Act. The DBRA Consultant would be responsible for documenting and ensuring that all construction contractors and their subcontractors follow EPA's Davis-Bacon and Related Acts (DBRA) "Wage Rate Requirements". This includes but is not limited to obtaining proper Wage Determinations from the US Department of Labor, Verification of Wage Decisions and Contractor Eligibility, Conducting Confidential Employee Wage Rate Interviews, Verification and Review of Contractor and Subcontractor Weekly Certified Payrolls and Statements of Compliance, Verification of Approved Apprenticeship/Trainee Programs, Verification of Fringe Benefits, etc. Ultimately, it is the water system's responsibility to ensure that the DBRA requirements are met.

Following are **2 (two) lists of approved DWRLF DBRA Consultants**. The first list, "**DBRA ADMINISTRATIVE CONSULTANTS**", strictly includes DBRA Consultants. The second list, "**DBRA ADMINISTRATIVE CONSULTING ENGINEERING FIRMS**", includes Engineering Firms that also have DBRA Consultants on staff. Any other candidates which wish to seek DWRLF approval and appear on this list simply need to make a request through contacting our office at 225-342-7499 and providing a DBRA experience-related resume to the DWRLF Program Engineer.
