



March 21, 2014 – Water Disinfectant Emergency Rule Monitoring

This report was prepared using compliance data due to the Department of Health and Hospitals by February 1, 2014. The Emergency Rule referenced was published in November 2013 and required that water systems in the state maintain a higher residual disinfectant level and increase their number of sampling sites by 25 percent. Most drinking water systems in Louisiana were required to meet this new higher standard by February 1, 2014.

The rule was written following discussions with scientists, federal officials, industry leaders and water system operators. The Emergency Rule is based on scientific data and recommendations from the federal Centers for Disease Control and Prevention (CDC) relative to the control of the *Naegleria fowleri* amoeba that was discovered in two public water systems in the state.
