Additional Terms and Conditions of Sewerage Treatment Plant Identification Tags

Manufacturer shall be responsible for attachment of tags only to individual-type sewerage systems that are "approvable", which are systems designed/constructed in accordance with applicable Louisiana Sanitary Code and inter-related provisions. Incidental or other alternate use/attachment of such tags to systems which are not approvable shall constitute improper use and shall not obligate OPH to issue any permit prescribed by LA Sanitary Code Part XIII Provisions. Also, a list, which includes name, address of purchaser, date of sale, ID tag number, etc. of all sales/installations of individual mechanical (residential) plants must be maintained by the individual and/or company purchasing the tags. Additionally, in the event the installation/site or other compromising circumstances may preclude other permit conveyance by OPH, similarly OPH shall not be obligated to manufacturer in any manner or form with respect to use of tags.

Regarding Shipping Rates:

All orders are sent via Priority Flat Rate, Certified, and Return Receipt Requested. Payment of shipping fees must be made at the time of the order. Priority Flat rates will accommodate an order of approximately 75 tags with a shipping cost of \$13.70. Orders exceeding 75 tags will be divided and shipped via separate Priority Flat Rate envelopes. These rates are subject to change dependant on the United States Postal Service fees.

OPH Reserves the right to limit provision of what it may consider to be an "excessive number" of tags requested. Under such circumstances orderer may be required to furnish written evidence to document order legitimacy, i.e. company sales records.

Manufacturer (or authorized representative, as appropriate, authorized by the department) shall be solely responsible for the proper use and care of tags, once provided same by OPH. Manufacturer shall hold harmless OPH in the event tags are lost, stolen, misplaced, or otherwise similarly compromised. In the event, however, that tags are lost, stolen, misplaced or otherwise similarly compromised, it shall be the responsibility of the manufacturer to duly apprise OPH of comprehensive details to sufficiently document such circumstances. **Tags are not a** marketable or transferable item and any individual sewage system installed in the State of Louisiana without the Sewage Identification Tag cannot and shall not be approved.
