# Overview of RWHAP and HOPWA, and the Guidance and Application

- ▶ The Office of Public Health, STD/HIV/Hepatitis Program (SHHP) receives federal RWHAP funds under the Ryan White Treatment Extension Act of 2009 and HOPWA funds under the AIDS Housing Opportunity Act.
- ▶ RWHAP funds are specifically to support a comprehensive system of care for low-income persons with HIV through provision of core medical and support services to improve health outcomes and reduce HIV transmission. It is the largest federal program focused specifically on providing HIV care and treatment services to low-income people living with HIV. The United States Department of Health and Human Services, Health Resources and Service Administration (HRSA) administers RWHAP.
- ▶ HOPWA funds are for the provision of housing assistance and supportive services for low to moderate income persons living with HIV and their families. It is the only federal program targeted specifically to meeting housing needs of people living with HIV. The United States Department of Housing and Urban Development (HUD) administers HOPWA.

#### 2020 RFP Changes Compared to 2018

- ➤ Contracts awarded under this RFP will be on a cost reimbursement basis as opposed to a fee-for-services basis which was the case in prior contracts.
  - The amount billed each month for services provided will not be attached to the number of units billed. Time spent on activities will be tracked in CAREWare. Dollar for dollar services including oral health care, child care, emergency financial assistance, housing, medical transportation, referral, respite care, and other professional services will be entered into CAREWare and will draw down their associated indirect costs.
  - Cost proposal sheets are in writeable format in Excel. They have functions built in to total for you. They also have notes note/reminders on what costs can be considered administration cost. Please also be sure to review the Policy Clarification Notices in the Procurement Library regarding these key requirements.
- ▶ The Bundled Services list has increased from 6 to 10 service categories. This RFP is primarily directed towards the provision of Bundled Services note: proposals should cover all Bundled Services. Optional service budgets will be requested during contract negotiation with the successful proposers.



  - General overview of the organization, experience serving the relevant communities, and capacity to provide RWHAP and HOPWA services
- ▶ Approach and Methodology 25 pts
  - Description of approach in providing services including operational and administrative structures that enable provision of quality services
- ▶ Proposed Staff Qualifications 13 pts
  - Detailed description of organizational staffing and qualifications
- ▶ Louisiana Veteran and/or Hudson Initiative 12 pts
  - Description of agency's classification as Veteran and/or Hudson Initiative small entrepreneurship based on ownership designation as such or use of one in the performance of contract work resulting from this RFP
- ► Cost 25 pts
  - Detailed line item budget description of direct and administrative costs associated with service delivery and administration of the contract, including travel, supplies, data management, client satisfaction, etc.
- ► Maximum Score 100




#### Legal Considerations


- ▶ Louisiana Board of Ethics: Proposers shall be responsible for determining that there will be no conflict or violation of the Louisiana Ethics Code if their company is awarded the contract. Any potential conflict of interest that is known or should reasonably be known by a proposer as it relates to the RFP should be immediately reported to the Department by proposer.
- ▶ **Blackout Period:** We are currently in the blackout period until the contract is awarded. All communications to and from potential Proposers, bidders, vendors and/or their representatives during the blackout period must be in accordance with this solicitation's defined method of communication with the RFP Coordinator, Capucinca Harris-Roberts.
- ▶ If you are a Proposer and also an current contractor, the State and the contractor may contact each other with respect to the existing contract only. Under no circumstances may the State and the contractor and/or its representative(s) discuss the blacked-out procurement.
- ▶ Any bidder, Proposer, or state contractor who violates the blackout period may be liable to the State in damages and/or subject to any other remedy allowed by law.




















#### Who is being newly diagnosed with HIV?






# Persons Living with HIV Louisiana, 2004 - 2019








# HIV Care Continuum Louisiana, 2019








# HIV Care Continuum by Race/Ethnicity Louisiana, 2019








# HIV Care Continuum by Age Group Louisiana, 2019




