## 6. Report: Medical Service/Delivery

Amanda Dumas, M.D., Associate Director of Louisiana Medicaid presented an annual review of Medicaid coverage for sickle cell disease per the "Lorri Burgess Law" (Act 670, RS 2022).

## 7. Report: Patient Navigation

Information was provided on support to the foundations from Geoff Nagle with Alliance Strategic Advising and Research.

The commission discussed receiving information for patients with sickle cell disease and funding for sickle cell disease.

The commission asked that the Families Helping Families model is shared with the foundations.
