VII. New Business

a. RDAC Patient/Advocate Story | Dr. Latasha Holt

Dr. Latasha Holt is an assistant professor at the University of Louisiana at Lafayette. Her daughter, Blakely, was diagnosed with adrenal insufficiency and epilepsy. Adrenal insufficiency is when the adrenal glands don't produce enough cortisol and aldosterone. Epilepsy is a chronic brain disorder characterized by recurrent seizures, which are brief episodes of involuntary movements, loss of consciousness, or altered awareness. She shares her experiences of managing Blakely's care in hopes of helping families and teachers avoid misinformation and potential errors in care.

b. Rare Disease Day 2025/Event at the State Capitol

Rouse and Williams announced that the RDAC is hosting a Rare Disease Day event on February 28 at the Louisiana State Capitol Formal Gardens in Baton Rouge, La. This event is designed to promote advocacy, inclusivity, and strengthen the rare disease community in the state. The event is free and open to the public. Guests expected to attend include Miss. Wheelchair Louisiana, Miss. LSU, Miss. Southeastern University, state government officials, industry representatives, RDAC members, medical providers, and many more. Vendors and volunteers are encouraged to sign up. The deadline for vendors to register is 2/21/25.

She shared that the Immune Deficiency Foundation has school programs for children with primary immune deficiencies and the Kansas City Hospital hosts an annual event on transitioning from pediatric to adult care.
