# **VENDOR UPDATES**

LA WIC recently made changes to the Minimum Stock Requirements (MSRs) as reflected in the LA WIC Vendor Guide, revised 10/2020. These changes are effective as of October 12, 2020. As a reminder, the Vendor Guide and Vendor Agreement state each Vendor should have the current WIC Approved Foods List (WIC-23) posted at each register at all times.
